**SECTION 2:**

**ALLOWANCE CALCULATIONS**

1) To apply for Early Adopter allowances, first commence an eligible Energy Efficiency and Conservation, Renewable Energy, Clean Technology, Air Pollution Control Upgrades, or Clean Coal Technology project between July 1, 2006 and December 31, 2012, then complete that project's appropriate Clean Air Set-Aside form. The allowance data calculated from those forms is then used to populate this form for the Early Adopter allowance calculation. Early Adopter allowances are eligible for a total of ten control periods, therefore also enter the submittal number for the particular request below and label the period with an "S" for seasonal or an "A" for annual.

$$A = 1.0 + 0.10 \times \sum A_i$$
