PUBLIC NOTICE OF DRAFT HAZARDOUS WASTE PERMIT RENEWAL

The Illinois Environmental Protection Agency (IEPA) and U.S. EPA hereby give notice of intent to renew a Resource Conservation and Recovery Act (RCRA) permit held by Clean Harbors Recycling Services of Chicago, LLC for their Chicago Recycle Center at 1445 W. 42nd St., Chicago, IL 60609. The renewed permit would allow the facility to continue to store RCRA hazardous wastes in existing tanks and containers, and to construct new RCRA hazardous waste storage tanks (this additional tankage had been permitted previously but not constructed).

Any public hearing request must be made in writing, state opposition to the draft permit and the nature of issue(s) to be raised at the hearing. Commenters will be notified of the permit decision and the respective appeal process.
