## Illinois Environmental Protection Agency Notice of Public Comment Period and Public Hearing Section 401 Water Quality Certification for Winnebago Landfill

The Illinois Environmental Protection Agency (Illinois EPA) Bureau of Water has received an application for a Section 401 Water Quality Certification (Agency Log No.C-0211-21) for impacts associated with construction of two soil stockpiles. The proposed project is located in Winnebago County and Ogle County, Illinois. The property is bordered by Interstate 39 to the east, Edson Road to the south, Lindenwood Road to the west, and agricultural fields to the north. The proposed project establishes two stockpile areas to provide additional accommodation for the five million cubic yards of clean earthen material generated from the 222-acre landfill expansion.

Winnebago Reclamation Services, Inc., also known as Rock River Environmental Services, previously received local, state, and federal authorizations to expand its existing landfill. Stockpile 1 is a 90-acre parcel south of Edson Road immediately east of Kilbuck Road. As future cell development in the Eastern Expansion Unit (EEU) continues, Stockpile 2 is proposed for temporary clean soil stockpiling in six acres of the southwest corner of the EEU. Stockpile 2 will discharge to a small intermittent drainageway north of the proposed stockpile.

The Illinois EPA is holding a public comment period and public hearing to offer an opportunity to the public to provide both written and oral comments on this proposed action prior to making a final decision on the Section 401 Water Quality Certification. The Illinois EPA is accepting written public comments on the application for a Section 401 Water Quality Certification until 11:59 p.m. CT, Monday, January 10, 2022. In addition to accepting written public comments, the Illinois EPA Bureau of Water will hold an online (virtual) public hearing beginning at 6:30 p.m. CT on Thursday, December 9, 2021 to receive comments from the public concerning the application for a Section 401 Water Quality Certification. Lengthy comments should be submitted in writing. The hearing will be held pursuant to 35 Illinois Administrative Code Part 164. The Illinois EPA will present opening statements concerning the draft permit and hearing procedures prior to accepting comments from the public during the hearing.

The Illinois EPA issues water quality certifications pursuant to Section 401 of the federal Clean Water Act (CWA). This certification must be granted or waived prior to issuance of any federal permit that authorizes a potential discharge of dredged or fill material to a waters of the U.S. CWA Section 401 specifies that the Illinois EPA must determine whether the proposed activities would meet the state water quality standards at 35 Illinois Administrative Code, Subtitle C: Water pollution. The Illinois EPA technical review focuses on potential impacts on water quality caused by the proposed construction and alteration of the waterbody. A 401 certification granted by the Illinois EPA may contain conditions and monitoring requirements deemed necessary to assure compliance with water quality standards or other applicable requirements. Conditions placed in the certification become conditions of the federal permit. The certification request may be denied if the Illinois EPA determines that applicable water quality standards or other requirements would not be met.
