Commenters may include a request for public hearing. Only hearing requests and comments that pertain to Clean Water Act Section 401 authority will be considered. This authority provides consideration of whether the permit or license would be consistent with Sections 301, 302, 303, 306, or 307 of the CWA, as well as "any other appropriate requirement of State [or tribal] law". Requests for additional comment period must provide a demonstration of need. The final day of comment acceptance will be on the Public Notice Ending date shown above, unless the IEPA grants an extended notice period. The attached Fact Sheet provides a detailed description of the project and the findings of the IEPA's antidegradation assessment.

If written comments or requests indicate a significant degree of public interest in the certification application, the IEPA may, at its discretion, hold a public hearing. Public notice will be given 30 days before any public hearing. If a Section 401 water quality certification is issued, response to relevant comments will be provided at the time of the certification. 401 Water Quality Certification Fact Sheet for Stephens Bike Trail

The Village of Lemont is proposing to construct a new bike trail along the Stephen Street corridor from the Illinois and Michigan Canal in downtown Lemont north to Centennial Trail. From the I&M Canal north to just north of the BNSF Railroad viaduct, the proposed trail will be an on-street bike route with no improvements to the roadway. North from the BNSF Railroad, the proposed trail will be an off-street trail primarily within the old Stephen Street road right-of-way. It will continue north to the Centennial Trail. Included is a new bridge over the Sanitary and Ship Canal. The proposed bridge will be a single span truss bridge that will span the entire channel. The bridge abutments will be placed approximately 10 feet behind the edge of the waterway. Cranes will be utilized to install the truss bridge. A wetland report was prepared by GZA that indicated no wetlands will be impacted by the proposed improvement.

Since the proposed bridge over the Sanitary and Ship Canal will span the entire waterway, there will be no dredging of material from the Canal. The south bridge abutment and the center pier will both be located on ground set back from the edge of the waterway. No drainage structures are part of the project. Therefore, there will be no direct discharge of stormwater to the Canal. All runoff from the proposed trail will be sheet flow as it currently exists. Temporary erosion control barrier will be installed around the entire construction site. Once the permanent ground cover is established upon completion of the project, the temporary erosion control barrier will be removed.

Due to the lack of impacts proposed, an antidegradation assessment is not required for this project.
