PUBLIC NOTICE OF HAZARDOUS WASTE PERMIT
Honeywell International Inc. in Cicero

The Illinois Environmental Protection Agency (Illinois EPA) hereby gives notice of intent to approve a Resource Conservation and Recovery Act (RCRA) corrective action only permit for the Honeywell International Inc. (a.k.a. former Baron-Blakeslee) facility. The facility is located at 1620-1634 South Laramie Avenue, Cicero, Illinois 60804 (Site ID: 0316000037; Permit Log No: B-218). The Permittee for this facility is Mr. George Pfeiffer of Honeywell International Inc, with a mailing address at 114 Tabor Road, Morris Plains, New Jersey 07950. Honeywell International Inc. is an existing facility that was first issued a RCRA permit on September 25, 1989, which allowed for the storage of hazardous waste solvents in containers and tanks at portions of the 5-acre property. As the RCRA permit eventually expired on October 31, 1999, upon the request of the Illinois EPA, Honeywell International Inc. submitted a RCRA permit application to apply for a new corrective action only permit to complete any remaining corrective action at the site under RCRA corrective action, also known as hazardous waste cleanup. The application addresses the continuation of corrective action for three areas of concern (AOCs) at the site, any remaining closure of 14 hazardous waste management units (HWMUs) under corrective action, and the implementation of a groundwater corrective action program meeting the requirements of Title 35 Illinois Administrative Code (35 IAC) 724.201.

Written comments on the draft corrective action permit may be submitted during the 45-day comment period. **Send comments to the Illinois EPA contact listed at the end of this notice postmarked by 11:59PM, November 3, 2025.** In response to public requests or at the discretion of the Illinois EPA, a public hearing can be held to clarify technical issues concerning the draft corrective action permit. A public hearing request must be made in writing, express opposition to the draft corrective action permit and state the nature of the issue(s) to be raised at the hearing. Written hearing requests should be sent to the Illinois EPA contact listed below by the end of the comment period. Public notice will be issued 45 days before any hearing.

All comments received will become part of the Administrative Record (AR) and will be evaluated by the Illinois EPA in making the final permit decision. Illinois EPA will respond to comments on the draft permit and indicate whether additional documents have been included in the AR. Commenters will be notified of the final permit decision and the permit decision appeal process.

The facility is located in an area of Environmental Justice concern. More information concerning Environmental Justice may be found at <https://epa.illinois.gov/topics/environmental-justice.html>.
