Illinois Environmental Protection Agency PUBLIC NOTICE OF CORRECTIVE ACTION PERMIT Kinder Morgan Liquids Terminal, LLC in Hartford and Wood River

The Illinois Environmental Protection Agency (EPA) hereby gives notice of intent to approve a new Resource Conservation and Recovery Act (RCRA) corrective action only permit for Kinder Morgan Liquids Terminal LLC (KM Terminal), owned and operated by Kinder Morgan Phoenix Holdings LLC (KMPH). The facility is located at 1000 BP Lane in Hartford, Illinois (Site ID: 1190505061; Permit Log No. B-214). KM Terminal's 118-acre property was acquired in 2016 from BP Products North America (BP), who had and still maintains an existing RCRA corrective action only permit for its Main Plan facility (Site ID: 1191150001; Permit Log No. B-147R). This draft permit, once finalized, will require KMPH to conduct site-wide corrective action at the KM Terminal's 118-acre facility from the ground surface down to a depth of 408 feet above Mean Sea Level (MSL) (approximately 20' below ground surface of the property) while BP maintains the RCRA corrective action responsibility for soil and groundwater below 408' MSL.

Written comments on the draft post-closure renewal permit may be submitted during the 45-day comment period. Send comments to the Illinois EPA contact listed at the end of this notice postmarked by midnight, November 13, 2023. In response to public requests or at the discretion of the Illinois EPA, a public hearing can be held to clarify technical issues concerning the draft corrective action permit. A public hearing request must be made in writing, express opposition to the draft corrective action permit and state the nature of the issue(s) to be raised at the hearing. Written hearing requests should be sent to the Illinois EPA contact listed below by the end of the comment period. Public notice will be issued 45 days before any hearing.

All comments received will become part of the Administrative Record (AR) and will be evaluated by the Illinois EPA in making the final corrective action permit decision. The Illinois EPA will respond to comments on the draft corrective action permit and indicate whether additional documents have been included in the AR. Commenters will be notified of the final corrective action permit decision and the permit decision appeal process.

The AR, including the permit application, draft corrective action permit, related information and all data submitted by the applicant, is now available for public inspection by appointment only Monday through Friday between 8:30 a.m. and 4:30 p.m. Please telephone or email the Illinois EPA contact below for an appointment to view the documents at Illinois EPA's offices in Springfield.
