**PUBLIC NOTICE OF HAZARDOUS WASTE PERMIT**  
**BP Products North American Inc./Main Plant in Wood River and Hartford**

The Illinois Environmental Protection Agency (EPA) hereby gives notice of intent to approve a Resource Conservation and Recovery Act (RCRA) corrective action only permit for the BP Products North American Inc. (BP) Main Plant facility. The facility's mailing address is 301 Evans Avenue, PO Box 167, Wood River, Illinois 62095. The Main Plant is located at 301 Evans Avenue in Wood River (Site ID: 1191150001; Permit log No: 147R2). BP Products North American Inc. Main Plant's approximately 569 acres property is currently operating under a RCRA permit. The application addresses the continuation of site-wide corrective action and also redefines the BP facility boundary to 450.75-acre by removing a portion of the land purchased by KM Phoenix Holdings LLC (KMPH) as KMPH is addressing any corrective action remaining at the portion of the land under its RCRA Corrective Action Only permit (issued on March 4, 2024; effective on April 8, 2024).

Written comments on the draft corrective action renewal permit may be submitted during the 45-day comment period. **Send comments to the Illinois EPA contact listed at the end of this notice postmarked by 11:59PM, November 14, 2024.** In response to public requests or at the discretion of the Illinois EPA, a public hearing can be held to clarify technical issues concerning the draft post-closure renewal permit. A public hearing request must be made in writing, express opposition to the draft corrective action renewal permit and state the nature of the issue(s) to be raised at the hearing. Written hearing requests should be sent to the Illinois EPA contact listed below by the end of the comment period. Public notice will be issued 45 days before any hearing.

All comments received will become part of the Administrative Record (AR) and will be evaluated by the Illinois EPA in making the final corrective action renewal permit decision. The Illinois EPA will respond to comments on the draft corrective action renewal permit and indicate whether additional documents have been included in the AR. Commenters will be notified of the final corrective action renewal permit decision and the permit decision appeal process.
