



# ILLINOIS ELECTRIC VEHICLE REBATE PROGRAM APPLICATION FORM

## October 28, 2025 Application Cycle

**Rebates under this program are subject to fund availability.** Rebate amounts differ by income (see Instructions).

Illegible, incomplete, or late applications will be denied. Applicants will receive mail correspondence if the application is denied.

The rebate application must be postmarked within 180 days after the vehicle purchase date, and it must be postmarked on or after October 28, 2025, but no later than May 31, 2026, for this cycle.

No applications will be accepted by fax, email, or hand delivery. Applications must be printed and mailed to the address below and bear a postmark.

**Be sure to read the Application Instructions as the Illinois General Assembly revised the program in 2025 to implement new applicant income and vehicle purchase or selling price eligibility requirements.**

### Section 1: Eligible Applicant Income Certification

To qualify as an "eligible applicant" in the Illinois Electric Vehicle Rebate Program, the total combined gross income of the applicant and all persons over the age of 18 living at applicant's residence and who may not be claimed as a dependent but are related to applicant by blood, marriage, or adoption cannot exceed 500% of the federal poverty line. See the attached instructions and table for information on how to determine whether you are eligible to apply for an electric vehicle rebate based on household size and household gross income.

If applicant meets the criteria for being an "eligible applicant," check "Yes" to certify this status. If the applicant does not qualify as being an "eligible applicant," the Illinois EPA cannot process your application for a rebate.

# ILLINOIS ELECTRIC VEHICLE REBATE PROGRAM

## APPLICATION INSTRUCTIONS

### REBATE AMOUNTS

For this rebate cycle, the rebate amount for an applicant that meets the Low Income criteria (see Section 2) is \$4,000 for the purchase of a new or used electric vehicle. For applicants that do not meet the Low Income criteria, the rebate amount for the purchase of a new or used electric vehicle is \$2,000. For all applicants, the rebate amount for the purchase of a new or used electric motorcycle is \$1,500. The rebate amount cannot exceed the purchase or selling price of the vehicle. To be eligible for a rebate, neither the applicant nor the electric vehicle or motorcycle can be the subject of a prior rebate. A searchable list of all electric vehicles and motorcycles that have already received a rebate can be found under “VIN Lookup” on the Illinois Electric Vehicle Rebate Program website.

### MAILING ADDRESS

The rebate application with required information and documentation must be printed and mailed to the Illinois EPA. Applications **will not** be accepted by fax, email, or hand delivery. Applications must be mailed to the address below and contain a postmark.

### APPLICATION DEADLINE

The rebate application must be postmarked within 180 days after the vehicle purchase date, **and** it must be postmarked on or after October 28, 2025, but no later than May 31, 2026, for this cycle.

### COMPLETENESS REQUIREMENT

All information requested in the application must be provided in legible fashion. Illegible, incomplete, or late applications will be denied.

### FUND AVAILABILITY

**All applications for an electric vehicle rebate are subject to fund availability.** Low Income applicants are prioritized for rebate issuance. Note that in previous fiscal years, funds were insufficient to cover all applications submitted during an open rebate cycle for applicants that did not meet the Low Income criteria. If you do not meet the Low Income criteria as described in Section 2, the earlier the application is submitted during the open rebate cycle the better the chances of receiving a rebate. A notice is posted on the Illinois Electric Vehicle Rebate Program website when it is determined that funds are insufficient to provide rebates for applicants not meeting the Low Income criteria during the remainder of the rebate cycle.

## APPLICATION

### Section 1: Eligible Applicant Income Certification

The Illinois Electric Vehicle Rebate Program was revised by the Illinois General Assembly in 2025 to implement an income limit for rebate eligibility such that the total combined household gross income of the applicant and all persons over the age of 18 living at the applicant's address and who may not be claimed as a dependent but are related to the applicant by blood, marriage, or adoption cannot exceed 500% of the federal poverty line for the current State fiscal year. In the table below, the combined gross income for all persons in the household as describe herein cannot exceed the dollar amount shown for the number of persons living at the residence ("Household Count"). For example, if there are four people living in your household, then the combined household gross income cannot exceed \$160,750 to be eligible to apply. If your total household gross income for the number of persons living in the residence exceeds the amount shown, then you are ineligible to participate in the Illinois Electric Vehicle Rebate Program as the Illinois EPA cannot process your application.

### Section 2: Low Income Certification

The eligibility for determining the Low Income criteria was revised by the Illinois General Assembly in 2025. It is now based on income levels and the number of persons in the household in the **County** that the applicant resides (e.g., the 102 counties in Illinois will have varying income levels that will define Low Income eligibility for this program). The Illinois Electric Vehicle Rebate Program now defines "low income" as persons and families whose income does not exceed 80% of the County median income for the current State fiscal year (July 1, 2025 - June 30, 2026), as established by the U.S. Department of Housing and Urban Development's (HUD) Illinois Income Limits. The regulations further provide that to qualify as "low income," the total combined gross income of the applicant and all persons over the age of 18 living at applicant's residence and related to applicant by blood, marriage, or adoption cannot exceed 80% of the County median income for the county that the applicant resides.

The link to HUD's Illinois Income Limits can be found on the homepage of the program website and below. To use this site in determining whether you qualify as a Low Income applicant, select "**Illinois**" as the state and then **select the County** that you reside. Click on "**View County Calculations.**" The "Income Limit Category" you are to focus on is "**Low (80%) Income Limits (\$)**" and NOT the Very Low Income or Extremely Low Income categories. Locate the number of persons in your family (household) and if your total household gross income is at or below the dollar amount shown in the "Low (80%) Income Limits" row, then you are eligible to be a "Low Income" applicant for this program and can certify such by checking "Yes" in Section 2 on the application form. If you do not qualify as "Low Income" for the county that you reside in, then do not check the box in that section.

### Section 3: Type of Application

- Check the “Original Application” box if this is your original (initial) rebate application.
- Check the “Reapplication” box if you have been issued a Denial Letter because your original application was incomplete and are resubmitting your application with the additional/missing information. In order to resubmit an application with additional/missing information to make the application complete, the vehicle purchase date must still be within 180 days of the postmark date of the resubmitted application, and it must meet all other eligibility criteria.

### Section 4: Applicant Information

- The applicant must be an individual and not a business or government entity or other entity such as a trust. Provide your name, physical street address (no P.O. Box), email address (if available), and your daytime or cell number (with area code). The daytime/cell phone number and email address are for contact purposes should that become necessary. Provide your mailing address if different from the physical address. The physical address will be used to confirm the Illinois residency requirement. Note that the IRS W-9 or W-8 information **must match** the information on file with the IRS. Rebate checks issued by the Comptroller will be mailed to the address on your W-9 or W-8 form, which must be the physical or mailing address provided in this section of the application.
- Check each of the statements acknowledging that you understand and meet the listed program eligibility criteria to receive a rebate.

### Section 5: Vehicle Information

- The Illinois Electric Vehicle Rebate Program was revised by the Illinois General Assembly in 2025 to implement a limit on the purchase or selling price for rebate eligibility. An eligible electric vehicle cannot have a purchase or selling price that exceeds \$80,000 as shown on the bill of sale, purchase invoice, or purchase agreement to receive a rebate. State and local taxes, license and registration fees, document service fees, and aftermarket products, including, but not limited to, extended warranties, service contracts, and other voluntary vehicle products, are excluded from the purchase or selling price if separately itemized on the bill of sale, invoice, or purchase agreement. Down payments, the trade-in value of another vehicle, manufacturer rebates, and government incentives and credits will not be considered in determining the vehicle's purchase or selling price. Illinois EPA will determine eligibility by finding the vehicle's purchase or selling price on the bill of sale, invoice, or purchase agreement, prior to all other fees and credits being applied. If the base purchase or selling price of the vehicle is \$80,000 or less, then it satisfies this requirement.
- Check whether this application is for an electric vehicle or an electric motorcycle. Per statute, an eligible electric vehicle or electric motorcycle is one that is exclusively powered by and refueled with electricity and is legally permitted to drive on all public roadways, including interstate highways. An eligible vehicle does not include those that are primarily intended to be driven off-highway, including golf carts and vehicles with a maximum speed below 45 miles per hour. Further, hybrid or extended range electric vehicles that are also equipped with conventional fueled propulsion or auxiliary engines are ineligible.
- Check whether you purchased a NEW or USED/PRE-OWNED electric vehicle or electric motorcycle from an Illinois dealer.
- Insert the purchase date of the vehicle.
- Insert the base purchase/selling price of the vehicle (before all other deductions and credits on the invoice).
- Insert the Make (manufacturer), Model, and Model Year of the vehicle or motorcycle.
- Insert the entire Vehicle Identification Number (VIN).

## Section 6: Dealership Information

This section should be completed by the selling Illinois dealership. Enter the name of the dealership, the dealership's license number issued by the Illinois Secretary of State, and the dealership's address and phone number. A representative of the dealership is to certify that the information in Sections 5 and 6 of the application are true and accurate with signature and printed name.

## Section 7: Documentation

Check each of the statements to ensure that the required documents and forms are included with the application. Legible copies of the documents are acceptable.

Proof of purchase documents must account for all money outstanding owed to the dealer on the bill of sale, purchase invoice, or purchase agreement. This can be a purchase document that shows the vehicle is paid in full with a \$0 balance, a statement from the dealership that the vehicle purchase amount has been paid, loan documents showing that the amount owed to the dealership has been financed, or a copy of one or more checks showing the amount owed to the dealership has been paid in full.

A copy of the Illinois vehicle registration or the temporary permit from the dealership (either a copy of the temporary permit card or a picture of the temporary permit mounted as a license plate showing the VIN) is needed to show an Illinois vehicle registration. A copy of the vehicle title is not the same as the vehicle registration and is not acceptable documentation to meet the registration requirement.

The links to the required IRS W-9 Form (if you have a social security number) and IRS W-8 Form (if you have a taxpayer identification number) are provided on the program website. The Illinois Office of Comptroller requires an individual's social security number or a taxpayer identification number to process payment and issue a state check for the rebate. The application cannot be processed without a completed W-9 or W-8, and as such would be deemed incomplete and denied.

The IRS W-9 or IRS W-8 information **must match** the information on file with the IRS. Rebate checks issued by the Comptroller will be mailed to the address on your W-9 or W-8 form, which must be the physical or mailing address provided in Section 2 of the application.

## Section 8: Authorization

Please read the authorization certification and, if in agreement, sign, print name, and date the application. By affixing the required signature in Section 8, the applicant is certifying that the overall application and all information provided, including certifications in Section 1 and, if applicable, Section 2, are true, accurate, and complete. The failure to sign the authorization in this section will cause the application to be deemed incomplete. This incompleteness will result in denial of the application.

## Additional Information

In 2025, the Illinois General Assembly authorized the Illinois EPA to request from a rebate recipient additional information and documentation evidencing eligibility for a rebate issued for auditing purposes. This could include requests for copies of income tax returns that corroborate the certifications in Section 1 (being an eligible applicant) and, if applicable, Section 2 (being eligible for the Low Income priority as determined by the applicant's county of residence). If requested, a rebate recipient shall provide the information and documentation within a timeframe specified in the Agency's request. If the rebate recipient fails to provide the requested information and documentation by the specified deadline, or if the information and documentation provided evidence that the rebate recipient was not eligible for a rebate or was not eligible to receive the Low Income priority, the rebate recipient shall be required to reimburse the Agency all or part of the original rebate amount.
