### **Executive Summary**

Section 25(h) of the Drycleaner Environmental Response Trust ("DERT") Fund Act requires the Illinois EPA to prepare a report in calendar year 2021 reflecting the status of the DERT Fund ("the Fund"), identifying expenses from the Fund, and identify drycleaning facilities within the state that are eligible for reimbursement from the Fund that have complete remedial action. This report satisfies that requirement.

#### **Background**

On August 19, 1997, P.A. 90-502 was signed into law creating the Fund and establishing the Drycleaner Environmental Response Trust Fund Council. The Council was comprised of seven individuals involved in the drycleaning industry in various capacities that were appointed by the Governor for three-year terms. The Council was responsible for administering the Fund, which included reviewing and authorizing reimbursement to claimants for eligible expenses related to remedial activities undertaken at current and former drycleaning sites. The Council was also responsible for licensing drycleaning facilities and overseeing environmental insurance coverage and reimbursement from the Fund.

The DERT Fund Act authorized the Council to adopt rules governing its programmatic processes. In 1999, the Council proposed such rules, which were adopted at 35 Ill. Adm. Code Part 1500, and became effective on January 1, 2000. The Council was not subject to Illinois EPA oversight and was not otherwise subject to Illinois EPA or Illinois Pollution Control Board ("Board") regulation.

On August 16, 2019, Governor J.B. Pritzker signed P.A. 101-400 into law, which amended the DERT Fund Act. The primary effect of the public act was to transition administration of the Fund and compliance with the DERT Fund Act from the Council to the Illinois EPA. This transition involved, among other things, the Illinois EPA overseeing drycleaning facility licensing and the review and payment of cost claims under the DERT Fund Act. The public act also authorized the Board to adopt rules governing the administration of the authorities shifted to the Illinois EPA.

The Council was statutorily abolished, effective June 30, 2020. In the months preceding the Council's abolition, the Illinois EPA engaged the Council in an active dialogue to ease transition of the Fund's administration to the Illinois EPA. This discourse included a thorough evaluation of the Council's rules and the most appropriate means to transition the programmatic functions. Effective July 1, 2020, administration of the DERT Fund resides with the authority granted by statute to the Illinois EPA.

With the abolishment of the Council on June 30, 2020, on July 1, 2020, the former Council's rules became, by statute, Board rules. On February 9, 2021, the Illinois EPA filed a rulemaking proposal with the Illinois Pollution Control Board to similar to the existing rules and also reflect the current administration of the Fund by the Illinois EPA. As of the date of this Report, those rules have not yet been adopted.

## **DERT Fund Overview**

As of July 1, 2021, the Fund had a balance of 1,261,292.95. During State Fiscal Year 2021, the Fund generated \$963,953.17 of revenue. Also during State Fiscal year 2021, two categories of costs paid from the Fund: administrative expenses for the Illinois EPA's oversight of the Fund and reimbursement of remediation claims. Section 10(f) of the DERT Fund Act limits the Illinois EPA's to administrative expenses to no more than \$600,000 per State Fiscal Year. During State Fiscal Year 2021, the Illinois EPA incurred \$237,178.05 of such expenses. This included salaries and fringe benefits of employees whose responsibilities included reviewing license applications, remedial action applications, requests for payment, and other submissions related to the Illinois EPA's administration of the Fund. In addition, the Illinois EPA approved and paid \$323,967.76 of remedial action claims from the DERT Fund in State Fiscal Year 2021. In total, the Illinois EPA approved 82 claims from 65 sites, ranging in value from \$107.62 to \$32,712.18.

#### Sites Eligible for Reimbursement

During the transition of the administration of the Fund, the Illinois EPA received records reflecting outstanding approved remedial actions from the Council. The Illinois EPA reviewed those records to confirm the roster of sites that previously submitted approvable budgets and work plans for cleanup work necessary to address drycleaning-related releases. As of July 1, 2021, there are 77 drycleaning facilities that are currently eligible for reimbursement from the DERT Fund for approved remedial actions activities. Those sites are:
