Weaver Consultants Group North Central, LLC (WCG) has prepared this letter on behalf of 300 West LLC to provide a quarterly report for the third quarter of 2015. Below is a list of items that were completed during the third quarter.

- Preparation of a proposed revised supplemental off-site groundwater investigation plan dated July 31, 2015. The revised supplemental off-site groundwater investigation plan summarizes select modifications to an initial supplemental off-site groundwater investigation plan dated June 10, 2015.
- Preparation of an August 19, 2015 letter to the Illinois Environmental Protection Agency (IEPA) in response to an IEPA letter dated July 27, 2015 concerning a recently completed on-site soil assessment and a proposed supplemental on-site soil assessment. The August 19, 2015 letter to the IEPA provides proposed modifications to a proposed initial supplemental on-site soil assessment work plan summarized in a letter dated June 30, 2015.
- Supplemental evaluation of the effectiveness of the proposed drinking water treatment system design.
- Third quarter sampling and laboratory analysis of private residential water supply wells and the preparation of a private residential water supply analytical summary.
- Review and formulation of conceptual groundwater remediation approaches.
- Preparation of a September 14, 2015 letter to the IEPA in response to an August 14, 2015 IEPA letter and a September 1, 2015 meeting with the IEPA. The September 14, 2015 letter summarizes select modifications to the proposed revised supplemental off-site groundwater

investigation plan dated July 31, 2015 as discussed during the September 1, 2015 meeting with the IEPA.

- Implementation of the supplemental off-site groundwater investigation field activities pursuant to the aforementioned September 14, 2015 letter.
- Supplemental on-site groundwater sampling and laboratory analyses.
- Preparation of a supplemental on-site groundwater assessment summary report dated
   September 30, 2015.

Below is a list of items that are anticipated to be in progress during the fourth quarter of 2015.

- Implementation of the supplemental off-site groundwater investigation field activities with laboratory analyses. Potential delays may result due to authorization of access agreements with the McHenry County Conservation District, weather, and off-site drilling conditions.
- Implementation of supplemental on-site soil and groundwater assessment field activities with laboratory analyses.
- Sampling and laboratory analysis of private residential water supply wells.
- Preparation of supplemental on-site soil and groundwater assessment summary reports.
- Preparation of supplemental off-site groundwater assessment summary report.
- Preparation of a Comprehensive Site Investigation report.
