SUBJECT: City of Cahokia Heights – Lift Station Rehabilitation-16 Locations

I have reviewed the Contract Documents and Specifications and supporting documentation received by the Permit Section on May 10, 2024, from the Watershed Management Section for the City of Cahokia Heights. The project consists of converting six (6) existing sewage eductor lift stations and two (2) existing suction lift stations to submersible duplex lift stations. The work includes removal and replacement of lift station pumps, control panels, valves, pressure gauges, guide bars, float switches, lift cables, disconnect switches, power and alarm cables, discharge pipe, force main, wet well lids, valve vaults, access hatches, and fencing, together with a restoration of all disturbed surfaces and all other incidental work required to complete the project.

The project has already been issued permits for the eight (8) following lift stations:
