Service Line Material Inventory (2017) Public Act 09-0922, 415 ILCS 5/17.11 (*repealed)

- Lead Service Line Inventory Background
 - Illinois Material Line Inventory (2017)
 - Requirements
- Adopted 2017
- By 2018, each community water system required to develop and submit annually a water distribution system material inventory to the Agency.
- Material inventory to be updated annually until considered complete.
- The inventories identified:
 - the total number of service lines within or connected to the distribution system, including privately owned service lines;
 - the number of all known lead service lines within or connected to the distribution system, including privately owned lead service lines; and
 - the number of the lead service lines that were added to the inventory after the previous year's submission.



National Primary Drinking Water Regulations-Lead Service Line Replacement

- Requirements for State primacy (40 CFR 142, Subpart B)
- The State must adopt and implement regulations for contaminants regulated under the National Primary Drinking Water Regulations that are no less stringent than the regulations promulgated by EPA.
- 40 CFR 141.84 Lead and Copper Rule Revisions (LCRR)
- Effective Date: December 2021
- Compliance Date: October 2024
- Requires:
- · Lead service line material inventory
- Lead service line replacement plan
- New federal rulemaking: Lead and Copper Rule Improvements (LCRI)



Illinois Lead Service Line Replacement and Notification Act (2022) – 415 ILCS 5/17.12

- Repealed and replaced the service line material inventory requirements found in the Illinois Environmental Protection Act at 415 ILCS 5/17.11.
- Effective January 1, 2022
- Requires (among other things):
 - Material inventory
 - Lead service line replacement plan
 - Lead service line Advisory Board



Lead Service Line Advisory Board -Duties

415 ILCS 5/17.12(y)

The Advisory Board shall have, at a minimum, the following duties:

- Advising the Agency on best practices in lead service line replacement;
- Reviewing the progress of community water supplies toward lead service line replacement goals;
- Advising the Agency on other matters related to the administration of the provisions in 415 ILCS 5/17.12.
- Advising the Agency on the integration of existing lead service line replacement plans with any statewide plan; and
- Providing technical support and practical expertise in general.



Lead Service Line Advisory Board -Funding Recommendations

415 ILCS 5/17.12(z)

Before July 1, 2023, report recommendations to the Governor and General Assembly concerning opportunities for dedicated, long-term revenue options for funding lead service line replacement while considering:

- Sufficiency of various revenue sources to adequately fund replacement of all lead service lines in Illinois.
- Financial burden, if any, on households falling below 150% of the federal poverty limit
- Revenue options that guarantee low-income households are protected from rate increases
- Assessment of the ability of community water supplies to assess and collect revenue
- Variations in financial resources among individual households within a service area
- Protection of low-income households from rate increase.



Lead Service Line Advisory Board-Status Report

415 ILCS 5/17.12 (aa)

Before January 1, 2032, prepare and deliver a report to the Governor and General Assembly concerning the status of all lead service line replacement within the State.



Rulemakings- 415 ILCS 5/17.12

415 ILCS 5/17.12(cc)

"...the Agency shall design rules for a program for the purpose of administering lead service line replacement funds."

415 ILCS 5/17.12(mm)

"The Agency <u>may</u> propose to the Board, and the Board may adopt any rules necessary to implement and administer this Section."
