Contest Rules, Information, and Timetable

Environmental Justice: A Healthy Community for All - Uplifting Community Voices!

Theme Focus: Understanding the need for environmental justice and why voices from overburdened communities (minority, low-income, tribal, or indigenous populations or geographic locations in the US that potentially experience disproportionate environmental harms and risks) are vital to the development, implementation, and enforcement of environmental laws, regulations, and policies

Participants: Illinois high school (9th – 12th grades) students

Poster and Poetry guidelines:

- Art paper or poster board no smaller than 8-1/2" x 11" and no larger than 12" x 18"
- Markers, crayons, pens, pencils, paints, or graphics software (two-dimensional media only)
- 1 page-long poetry maximum, (no larger than 8-1/2" x 11" sheet)
- Typed, minimum 10-pt. font for poetry
- **Must be own work**

Essay guidelines:

- 1000 words maximum length, (no longer than 3 pages)
- Typed; minimum 10-pt. font (no handwritten entries)

Entries must be submitted electronically (word, pdf, jpeg or tiff files).

The max number of entries per school is eight. Students may submit their entry individually.

NOTE: Each student must submit a release form and entry ID with his or her work. Only one person per entry (no group projects).

Each student's work will be judged on:

- Understanding of the concept
- Originality of execution -- no magazine articles, commercial slogans or copyrighted characters or figures
- Clear, accurate message
- Emphasis on the theme focus
- Neatness/attractiveness, legibility/readability, correct spelling, punctuation, and grammar
- Effort that was put into the work

Submission Process:

- Choose **eight entries** (four art and four written works) to represent your school (students may submit their entry individually if the entire class is not participating)
- Make sure completed identification forms are included
- Each entry must include a release form filled out and signed at the time of submission (students may sign their own if 18 years of age or older)
- Entries must be emailed no later than **February 1, 2023**
- Email entries, ID, and release forms (word, pdf, jpeg or tiff files) to: EPA.contest@illinois.gov

All entries become the property of the Illinois EPA and will be distributed for judging.

Contest Timeline and Resources

January 2023	Learn about Environmental Justice, what it means, why supporting marginalized groups creates a healthy environment for everyone, and how valuing all voices in a diverse range of communities, especially those in overburdened communities, fosters healthy environments for all.
January 17-20	Students create posters or written works relating to the theme focus: Environmental Justice: A Healthy Environment for All - Uplifting Community Voices!
January 23-27	If applicable, teachers display posters, poems and essays at their school. Students and faculty vote to select four posters/poems and four essay entries to submit to the Illinois EPA for further judging.
February 1	Students submit their entry, or teachers submit up to eight entries per school to the Illinois EPA for judging. Entries must be submitted electronically by February 1, 2023.

April 2023	Winners notified
