# ILLINOIS COMMISSION ON ENVIRONMENTAL JUSTICE MEETING MINUTES

## Discussion/Q&A

- Question, Delia Barajas (Cicero): What about general projects like Illinois EPA informing EJ communities when industries are in violation?
  - Answer: Organizations like Chicago Environmental Justice Network (CEJA) work on issues related to regulatory progress or enforcement. Organizations that are doing that work can get money and other support for various projects. If you want to focus on violations or failure to enforce, TCTACS can support those projects.
- Follow up question: There are more specific items, including violations in our community. Do the TCTACS help with that?
  - o Answer: Yes, we help with those types of activities.
- Question, Victoria Wilson: How can IEPA EJ Commission assist in getting the word out regarding services you
  offer? How can we encourage more project development at the state level to give back regarding something that
  maybe we can propose as one of our target goals at this commission to focus on.
  - Answer: If there is project implementation, projects on the Commission that are beneficial to EJ
    communities, there is matchmaking with government and industry, to advance community interest. We
    also have a newsletter to get the word out. We can get together to plan. We want to be facilitators.
- Question, Paulina Lopez-Santos: You mentioned there are 179 clients in the state of Illinois. Do you have a
  document that lists the projects that those clients are pursuing and the types of technical assistance they're
  requesting? The EJ Commission could potentially analyze those projects and work to reinforce some of the most
  common projects.
  - Answer: We have an unpublished granular database of what we are working on, but we could give you a short white paper of what we have by category, to bring a lens and a spotlight. There are ways we are looking at this in this early stage of how to bring government to the table and how we match them up with communities in need and really empower community-based organizations through funding and other resources to advance initiatives with government.
- Question, Ashish Sharma: Helpful for me to know which are the communities seeking technical assistance and what are the focus areas? Also, what are the efforts in big areas to address environmental concerns. And what are the distributions of those throughout the region?
  - Answer: This is a next step in our level of organizing services. This is a high leverage opportunity now. We can sit down with you and other agencies. We also have a spreadsheet of government offices that we want to make sure they have the word. We can publish and share the locations of organizations as well as their requests and priorities.

#### Illinois EPA Office of EJ (OEJ) Updates, Chris Pressnall

- Enhancements to Illinois EPA EJ webpage
  - Grant opportunities
  - Posting of EJ notification letters online starting May 1, 2024
- EJ Enforcement Policy
  - Finalizing + goal is to post and implement by end of year
- General Iron Informal Resolution Agreement, several deliverables
  - o Enhanced Public Participation Plan
  - Revised Language Access Plan
  - Plans are being discussed with the attorneys of the complainants, as well as U.S. EPA. These are due to go out to public notice and comment. We can discuss at the next Commission meeting. Language Access Plan and Disability Access Plan which are already out there but are being revised.
- Carbon capture & sequestration legislation
  - o Passed by the Illinois legislature although it may not have been signed by the Governor yet.

- Creates an EJ grant program, which we currently don't have in Illinois. Illinois EPA OEJ does not have independent funding.
- o 24% of carbon sequestration fees will be diverted to this fund, which creates a grant program. The dates are years down the line, but exciting, nonetheless.
- Legislation calls out the EJ Commission, reviewing progress reports on carbon sequestration.
- o This is for December 1<sup>st</sup> 2028.

## Discussion/Q&A

- Question, Delia Barajas (Cicero): Will you be including EJ communities like Cicero in plans?
  - Answer, Chris: Yes. The idea is to be more transparent in general throughout various points. The plans are all statewide plans, apply to all of Illinois.
- Question, Delia Barajas (Cicero): Why can't the Illinois EPA shut down industries that continue to harm our families over and over?
  - Answer, Chris: That is a complex question. When we find violations, we refer those to the Illinois
     Attorney General's Office and then it goes into the legal process. Andrew, do you have anything you'd like
     to add, or anybody else from the Attorney General's Office (AGO)?
  - Andrew Armstrong, AGO When IEPA finds violations of the Illinois Environmental Protection Act, those
    get referred to the AGO for enforcement. That process can take time while drafting and filing a court
    complaint. Any relief out of the defendant, they have to agree to it, or a court order is then needed to
    get them to do that. If the company does want to fight that, that can take a long time to try to get them
    into compliance.
- Follow-up question, Delia Barajas (Cicero): So then how do we protect our families, if this is such a long process, as it is with Koppers and now Electric Plating. In those years, this is all impacting our families. So is there not a way to protect our families?
  - Andrew Armstrong, AGO To get relief from a facility, we need to go through the established court
    process. The Illinois Environmental Protection Act does have citizen complaint procedures. With respect
    to the AGO enforcement work however, the established channels need to be followed.
- Question: How often are EJ assessments conducted in Illinois industries.
  - Answer, Chris In the Informal Resolution Agreement, IEPA has agreed to do EJ assessments for certain permits. It gets technical and is specific to major source or potentially major source, construction permits. Some of those assessments that have occurred are in the St. Louis Metro East area. This is a new development as well.
- Question, Victoria Wilson: Can we restate the focus and mission for this Commission specifically, so that we can refresh those who are new, and to make sure we are on task and focused on what our goals are?
  - o Answer, Chris: Yes. The link to our Commission on EJ flyer that outlines the mission is in the chat.
- Question/Comment, Juliana Pino, LVEJO: Thank you for the call to refocus. I do want to go back briefly to the CCS legislation. LVEJO worked on it alongside several other stakeholders in negotiation with the Governor's Office. A role for the EJ Commission explicitly and partly because this legislation emerged in a vacuum of regulation around CCS where the federal government put out large incentives for those activities that are highly underregulated in most states, as well as other issues like how companies are going to track and plan their intended capture activities. Important for the Commission to be involved in reviewing the progress of capture activities, including federal and state statutory requirements, reviewing proposals, and understanding proximity to EJ communities as well as thinking through the potential impacts for economically disadvantaged communities, etc., and how public participation processes associated with permitting could provide transparency and meaningful participation for EJ and other communities. Also gives the Commission space to make recommendations

## Additional Discussion/Q&A

Question, Clarification on dates for IEPA plans to go out for public comment?

- Answer: Enhanced Public Participation Plan will go out for public comment on July 13<sup>th</sup>. 30-day comment period. Language Access Plan out for public comment around September 11<sup>th</sup>. \*Timeline subject to change\*
- Question/Comment, Kim Wasserman: Although the Commission isn't meeting at that time, might be a place where Commissioners can collectively put together some comments to give back to the IEPA regarding public participation. I want to flag this opportunity to provide public comment for Commissioners. I would ask folks to think about the role of the Commission as well as the amount of people who have come to our meetings to express concern about how things have happened in the State. There has been public commentary given to us. It might benefit us to collectively, as a Commission, submit comments to that public participation process.
  - Answer from Commissioners generally: Commissioners in support of getting together to discuss providing comments as a Commission. Rules of the EJ Commission align greatly with this task – advising state entities on EJ-related policies, plans, laws, etc.
- Question/Comment, Andrew Armstrong (AGO): There has not been an annual report from the Commission for a
  while. I believe the last one was 2018. Should we also talk about that at our upcoming meeting? Additionally,
  given we are almost at quorum, should we also form a subcommittee to look at our work plan for 2025 to map
  things out?
  - Answer from Commissioners generally: In support of developing a workplan, vision for 2025 and including in report.

## Update and Discussion on Potential EJ Questions for State Agencies

- Kim Wasserman: Discussion on the EJ-related questions created for state agencies. Initially developed a few years ago to get a basic understanding of state agencies' development of EJ offices, programs, efforts, and initiatives. Open discussion on updating and revisiting these questions. Questions/thoughts? Open discussion.
  - Answer, Andrew Armstrong: Yes. Also, ask agencies how they define environmental justice and if it has a
    policy, what screens it would use for identifying EJ communities.
  - Answer, Juliana Pino (in chat): Are any of these agencies currently getting public input into their EJ work?
     What is public facing and what is going on exclusively behind agency doors?
  - Answer, Victoria Wilson: Additional funding coming from the federal government, new departments being developed, and who the points of contacts are at each agency, how they are engaging with the IEPA and other EJ divisions. How are state agencies working together. Would help Commission in defining work plan actions.
  - Answer from Commissioners generally: In support of updating and revisiting the questionnaire and voting on it at the next Commission meeting.
