V. Questions

- a. Tonyisha Harris Asked questions about future collaboration between the Commission on EJ and the Environmental Equity Working Group and the overall Cumulative Impact Assessment work. Commented about the Illinois EJ Permitting Act. Also asked why existing research/tools were not used.
- b. Andrew Armstrong Illinois Attorney General's Office Asked speaker to speak more about community benefits, what sorts of projects would be desirable in that regard.
- c. Donovan Griffith Asked what engagement looked like with the industry sector. Also asked about jobs impact in the community from this initiative, as well as how regulations may be implemented and what compliance would look like.
- d. Delia Barajas Asked about why a cumulative impact assessment is not being done at the state level and how many EJ communities exist in Illinois.
- e. Donovan Griffith responded to this mentioning that the state has been working on state-wide regulations for environmental justice, this work has been around for a few years now. EJ related bills have been introduced each year. This is something that EJ groups and industry groups have been working on. Active communication and work around this has been happening and we continue to work on passing statewide regulation that works for all stakeholders, ensuring that all people have both environmental and economic justice through whatever bill gets passed.
- f. Victoria Wilson Asked questions about previous reports under the last administration and why there must be another report (feasibility case study).

- g. Dulce Ortiz Commented about question about why this is not being done state-wide and getting more support from other colleagues doing similar work and working to become proactive instead of reactive.
- h. Victoria Wilson Commented about corporate accountability, federal mandates, and transparency regarding commitments from industry. What is the capacity of the city of Chicago to oversee and manage accountability process regarding the Chicago Cumulative Impact report.
- i. Sabrina Bailey Illinois EPA Office of Community Relations Asked a question about indexes and maps. Is there a scoring system or will indicators be used to score?
