The Illinois EPA has received applications for a Construction Permit and revised Federally Enforceable State Operating Permit for ADM/Growmark located at 1000 Wesley Road in Creve Coeur. The Construction Permit application is to modify the liquid urea process, removal of a boiler, and replacement of the barge loading conveyor. The source has also applied for a revision to Federally Enforceable State Operating Permit, which will incorporate construction permit 24070004.

The applications are currently under review by the BOA.
