In accordance with the Illinois EPA's Environmental Justice Policy, the Office of Environmental Justice wants to provide you with information about a potential action. The Illinois EPA is sending this letter to notify you of an application received by the Bureau of Air (BOA).

The Illinois EPA has received an application for a Construction Permit 24090007 from Archer Daniels Midland Co located at 4666 East Faries Parkway in Decatur. The application requests authorization for the construction of a peptide fermentation process at its Bioproducts Plant. The project involves repurposing existing equipment to produce peptides. Emissions from the fermentation tanks would be controlled by an existing scrubber.

The application is currently under review by the BOA.
