The Illinois EPA has received applications for a Construction Permit and revised Federally Enforceable State Operating Permit 96020027 for Bunge Grain Milling Inc located at 321 E. North Street in Danville. The Construction Permit application is to install a new fine grind process comprised of filter receivers, bin aspiration filter, and fine loadout bins and to replace an existing hammermill. The source has also applied for a revision to Federally Enforceable State Operating Permit, which will incorporate construction permit 24070030.

The applications are currently under review by the BOA.
