The Illinois EPA has received an application for a renewal of Federally Enforceable State Operating Permit 72110008 for Christ Bros Products LLC located at 6303 Collinsville Road in Collinsville. This facility operates a drum-mix asphalt plant.

The application is currently under review by the BOA. FESOP renewals require public notice. Once ready for review, the Illinois EPA will post a public notice and draft permit on its website (<https://epa.illinois.gov/public-notice/boa-notice.html>) and will accept comments during the public notice period. The procedures for public participation in the Air Pollution Control Permit Program can be found at 35 Ill. Adm. Code Part 252.
