In accordance with the Illinois EPA's Environmental Justice Policy, the Office of Environmental Justice wants to provide you with information about a potential action. The Illinois EPA is sending this letter to notify you of an application received by the Bureau of Air (BOA).

The Illinois EPA has received an application for a construction permit for CyrusOne CHI6 Facility located in the area south of Bryn Mawr Ave and west of Busse Rd in Wood Dale (this area does not yet have an official address). The application requests authorization to construct a data center that would consist of forty-two 2,250 kW emergency generators and two 1,250 kW emergency generators.

The application is currently under review by the BOA.
