The Illinois EPA has received an application for a renewal of Federally Enforceable State Operating Permit 02040026 from Daubert Cromwell LLC located at 12701 South Ridgeway Avenue in Alsip. This is a paper coating and printing facility.

The application is currently under review by the BOA. FESOP renewals require public notice. Once ready for review, the Illinois EPA will post a public notice and draft permit on its website (https://epa.illinois.gov/public-notices/boa-notices.html) and will accept comments during the public notice period.
