In accordance with the Illinois EPA's Environmental Justice Policy, the Office of Environmental Justice wants to provide you with information about potential actions. The Illinois EPA is sending this letter to notify you of applications received by the Bureau of Air (BOA).

The Illinois EPA has received applications for a Construction Permit and revised Lifetime Operating Permit (14070038) for Des Plaines Landfill located at 9800 W Central Road in Des Plaines. The Construction Permit application is for the replacement of an existing open flare (700 cubic feet per minute, cfm) by new flare with maximum design capacity of 350 cfm. The source has also applied for a revision to Lifetime Operating Permit, which will incorporate construction permit (24070011).

The applications are currently under review by the BOA.
