In accordance with the Illinois EPA's Environmental Justice Policy, the Office of Environmental Justice wants to provide you with information about a potential action. The Illinois EPA is sending this letter to notify you of an application received by the Bureau of Air (BOA).

The Illinois EPA has received an application for a Federally Enforceable State Operating Permit from E/M Coating Services located at 129 Eisenhower Lane South in Lombard. This facility produces plasma electrolytic oxidation coatings.

The application is currently under review by the BOA. FESOPs require public notice. Once ready for review, the Illinois EPA will post a public notice and draft permit on its website (<https://epa.illinois.gov/public-notices/boa-notices.html>) and will accept comments during the public notice period. The procedures for public participation in the Air Pollution Control Permit Program can be found at 35 Ill. Adm. Code Part 252.
