The Illinois EPA has received applications for a Construction Permit and revised Federally Enforceable State Operating Permit (18020010) for EdgeConneX located at 2055 Lunt Ave in Elk Grove Village. The Construction Permit application is for the addition of sixteen emergency generators and increased emissions limits of existing generators. The source has also applied for a revision to Federally Enforceable State Operating Permit, which will incorporate construction permit 24080001.

The applications are currently under review by the BOA.
