In accordance with the Illinois EPA's Environmental Justice Policy, the Office of Environmental Justice wants to provide you with information about a potential action. The Illinois EPA is sending this letter to notify you of an application received by the Bureau of Air (BOA).

The Illinois EPA has received an application for a Construction Permit for Elk Grove Village (CHI10-11) Data Center located at 201 Innovation Drive in Elk Grove Village. The application requests authorization to construct one 500 kWe diesel-fired emergency generator and twelve 3,100 kWe diesel-fired emergency generator sets and will be operated under the current permitted limits established in Construction Permit 20120040.

The application is currently under review by the BOA.
