The Illinois EPA has received an application for a renewal of Federally Enforceable State Operating Permit 05030054 for Formel Industries Inc located at 2355 25th Ave and 11323 Franklin Ave in Franklin Park. This facility manufactures custom flexible packaging products.

The application is currently under review by the BOA. FESOP renewals generally require public notice. Once ready for review, the Illinois EPA will post a public notice and draft permit on its website (<https://epa.illinois.gov/public-notices/boa-notices.html>) and will accept comments during the public notice period. The procedures for public participation in the Air Pollution Control Permit Program can be found at 35 Ill. Adm. Code Part 252.
