The Illinois EPA has received an application for a Construction Permit for Ingredient Inc located at 6400 S Archer Road in Bedford Park. The application requests authorization to construct a new anhydrous dextrose packaging operation. The construction project also includes a sugar silo, packing line, and two baghouses to control particulate emissions.

The application is currently under review by the BOA.
