In accordance with the Illinois EPA's Environmental Justice Policy, the Office of Environmental Justice wants to provide you with information about a potential action. The Illinois EPA is sending this letter to notify you of an application received by the Bureau of Air (BOA).

The Illinois EPA has received an application for a revision to Construction Permit 14100012 for Koppers Inc located at 3900 South Laramie Ave in Cicero. Koppers has applied for revisions to the permit for the construction of a new truck loading rack, reactivation of an existing truck loading rack, and authorization of naphthalene loadout at existing loading racks at the plant not previously authorized to load out naphthalene. An existing thermal oxidizer system would be utilized to control the emissions of volatile organic material from the loadout of naphthalene at these loading racks.

The application is currently under review by the BOA.
