The Illinois EPA has received an application for a Construction Permit for Koppers Inc located at 3900 S Laramie Ave in Cicero. Koppers Inc. has applied for a permit to expand the use of Tank T-41. The tank would serve as a backup for Tank T-49, with emissions controlled by existing equipment.

The application is currently under review by the BOA.
