The Illinois EPA has received an application for a renewal of Federally Enforceable State Operating Permit 95030004 for La-Co Industries Inc located at 1201 Pratt Boulevard in Elk Grove Village. This source operates a chemical compounds manufacturing plant.

The applications are currently under review by the BOA. FESOP renewals require public notice. Once ready for review, the Illinois EPA will post a public notice and draft permit on its website (<https://epa.illinois.gov/public-notices/boa-notices.html>) and will accept comments during the public notice period. The procedures for public participation in the Air Pollution Control Permit Program can be found at 35 Ill. Adm. Code Part 252.
