The Illinois EPA has received an application for a significant modification of Clean Air Act Permit Program (CAAPP) Permit 96030137 for Leisure Properties LLC dba Crownline Boats located at 11884 Country Club Road in West Frankfort. The application requests a minor modification of the facility's existing CAAPP permit for the addition a 6000-gallon resin storage tank.
