In accordance with the Illinois EPA's Environmental Justice Policy, the Office of Environmental Justice wants to provide you with information about a potential action. The Illinois EPA is sending this letter to notify you of an application received by the Bureau of Air (BOA).

The Illinois EPA has received an application for a revision of Construction Permit 19090017 for Mueller Co LLC located at 2675 North Jasper St in Decatur. The application requests an extension of the time to construct for several emission units. It also requesting to increase permitted emissions for natural gas combustion, equipment designations, emission factors, natural gas usage, testing requirements, recordkeeping, and exempt emission units. The source would operate under a FESOP permit, as their potential to emit (PTE) emissions are more than a major source threshold.

The application is currently under review by the BOA.
