The Illinois EPA has received an application for a renewal of Federally Enforceable State Operating Permit 05040029 from Pregis Polymask located at 515 N Enterprise St. in Aurora. This facility manufactures packaging products and machines.

The application is currently under review by the BOA. FESOP renewals require public notice. Once ready for review, the Illinois EPA will post a public notice and draft permit on its website (<https://epa.illinois.gov/public-notices/boa-notices.html>) and will accept comments during the public notice period.
