The Illinois EPA has received an application for a Construction Permit from Prime Data Centers located at 1600 E Higgins Rd in Elk Grove Village. The application requests authorization to construct the first phase of a new data storage facility. This phase will include 39 new diesel-fired generators for emergency backup.

The application is currently under review by the BOA.
