The Illinois EPA has received an application for a Federally Enforceable State Operating Permit for Quality Bags Inc located at 575 South Vista Avenue in Addison. This is a flexible packaging manufacturing facility.

The application is currently under review by the BOA. FESOP require public notice. Once ready for review, the Illinois EPA will post a public notice and draft permit on its website (<https://epa.illinois.gov/public-notices/boa-notices.html>) and will accept comments during the public notice period.
