This Environmental Justice notification letter is to inform you that the City of Chicago Dept. of Transportation - Division of Engineering is applying for a Section 401 Water Quality Certification pursuant to the Clean Water Act for the reconstruction of the Division Street Bridge over the North Branch of the Chicago River. The application requests to replace the existing bascule bridge with a new liftable tiered arch bridge. To keep traffic flowing on Division Street during construction, a temporary bridge will be built next to the current one. The Illinois EPA (IEPA) Bureau of Water (BOW) is reviewing the application. The Office of Environmental Justice welcomes your feedback.

The draft Water Quality Certification and instructions for submitting comments during the public comment period will be available on the IEPA's website (<u>https://epa.illinois.gov/public-notices/section-401-notices.html</u>) once it is ready for review.
