In accordance with the Illinois EPA's Environmental Justice Policy, the Office of Environmental Justice wants to provide you with information about a potential action. The Illinois EPA is sending this letter to notify you of an application received by the Bureau of Air (BOA).

The Illinois EPA has received an application for a renewal of Clean Air Act Permit Program (CAAPP) 08020036 for Seating Concepts located at 125 Connell Avenue in Rockdale. The application requests renewal of the facility's existing CAAPP permit for five years.

The application is currently under review by the BOA. CAAPP renewals generally require public notice. Once ready for public review, the Illinois EPA will post a notice and draft permit on its website (<https://epa.illinois.gov/public-notice/boa-notice.html>) and will accept comments during the public notice period. The procedures for public participation in the Air Pollution Control Permit Program can be found at 35 Ill. Adm. Code Part 252.
