In accordance with the Illinois EPA's Environmental Justice Policy, the Office of Environmental Justice wants to provide you with information about a potential action. The Illinois EPA is sending this letter to notify you of an application received by the Bureau of Land (BOL).

The Illinois EPA has received an application for a Household Hazardous Waste Collection Transfer Station, Permit Log No. 2024-210 for Solid Waste Agency of Lake Co HHW Transfer located at 1311 Estes Street in Gurnee. The application requests a revision to this Transfer Station permit to allow acceptance of household sealed lead acid batteries, acceptance of small propane and iso-butane cylinders, and allow the acceptance of universal waste on separate days from household hazardous waste. It also requests to increase open hours and add a new condition to allow acceptance of damaged, defective, or recalled batteries. The permit would be issued subject to the development, operating and reporting requirements for Solid Waste Facilities in 35 IAC, Part 807 regulations.

The application is currently under review by the BOL.
