The Illinois EPA has received an application for a Construction Permit 24050014 for Sonoco Flexibles located at 1950 Pratt Boulevard in Elk Grove Village. The application requests authorization to install a new regenerative thermal oxidizer (RTO) to replace an existing RTO and operate as the primary process volatile organic material emissions control unit.

The application is currently under review by the BOA.
