The Illinois EPA has received applications for a renewal of Federally Enforceable State Operating Permit 01110062 from US Truck Body located at 1807 North Bloomington Street in Streator. This source manufactures cargo boxes that are mounted on customer supplied chassis.

The applications are currently under review by the BOA. FESOP renewals require public notice. Once ready for review, the Illinois EPA will post a public notice and draft permit on its website (<https://epa.illinois.gov/public-notices/boa-notices.html>) and will accept comments during the public notice period. The procedures for public participation in the Air Pollution Control Permit Program can be found at 35 Ill. Adm. Code Part 252.
