The Illinois EPA has received applications for a Construction Permit and revised Federally Enforceable State Operating Permit 04070058 for Weber Packaging Solutions Inc dba Weber Marking Systems Inc located at 711 West Algonquin Road in Arlington Heights. The Construction Permit application is to add one narrow web flexographic printing press to their Arlington Heights facility. Additionally, the source is also requesting to remove various units from the facility, including one laser etching machine and one glue applicator. The source has also applied for a revision to their Federally Enforceable State Operating Permit, which will incorporate construction permit 17100014.

The applications are currently under review by the BOA.
