1. Introductions

Kay welcomed participants and called the meeting to order at 10:05am.

2. Approval of meeting minutes

Walter moved to approve the minutes for the 1-7-21 meeting and James seconded the motion. Motion passed unanimously.

3. Discussion on recommendations

**Recommendation #1**

Participants discussed whether funding should be included in the subcommittee's recommendation. James reported that the funding recommendation is consistent with the language proposed by other subcommittees. Donovan opposed the recommendation that the IEPA should investigate additional funding sources by a specified date. Walter and Kay expressed support for considering future funding options.

**Recommendation #2**

Walter requested that this section specifically mention an increase in proper recycling and a reduction of recycling contamination.

**Recommendation #3**

Participants discussed whether maps should include locations where entities other than residents can dispose of household items. Collection sites are typically for residents, so members debated the appropriate language. "Consumers" was suggested as a replacement for "residents." Members expressed the need for the IEPA to update maps and the entire website/webpage on a regular basis.

Walter suggested language to make information from the MRF and compost sites available to consumers that send material to the sites.

### Recommendation #7

Participants discussed whether developing an app to communicate information would be beneficial. James noted that utilizing current and emerging technologies, including apps, is an important component of education and outreach.

### Chat comments

Participants wrote in comments that include:

- Yes, specifically reference recycling contamination in recommendation #2
- Creation and updating of an app might not be a good use of IT time/resources
- Remove "materials recovery facilities and compost facilities" in recommendation #5. Leave language open so surveys can be conducted by the agency amongst all respective groups actively involved in recycling efforts from within each particular region of the state.
