Application for Permit for Clean Construction or Demolition Debris Fill Operations (LPC-PA25)

This form must be used to apply for permits for clean construction or demolition debris fill operations pursuant to Section 22.51 of the Illinois Environmental Protection Act. Permits are required only for sites where clean construction or demolition debris is being used as fill in a current or former quarry, mine, or other excavation. This application is not required for clean construction or demolition debris recycling sites, active mining operations, or permitted landfills unless clean construction or demolition debris is being used as fill at the site in a current or former quarry, mine, or other excavation.

V. CONFLICT OF INTEREST DISCLOSURE

Pursuant to Section 22.52 of the Illinois Environmental Protection Act, certain individuals are prohibited from having a direct financial interest in or receiving a personal financial benefit from (1) any waste disposal operation or any clean construction or demolition debris fill operation that requires a permit or interim authorization under the Illinois Environmental Protection Act, or (2) any corporate entity related to any such waste-disposal operation or clean construction or demolition debris fill operation. This prohibition does not apply to the ownership of publicly traded stock.

VI. COMPLIANCE WITH SECTION 39(i-5) OF THE ACT

Pursuant to Section 39(i-5) of the Environmental Protection Act, for any clean construction or demolition debris fill operation in which any ownership interest was transferred between January 1, 2005 and August 18, 2005, the Illinois EPA must conduct an evaluation of the operation if any previous activities at the site or facility may have caused or allowed contamination at the site. The Illinois EPA may deny a permit if previous activities at the site may have caused or allowed contamination at the site, unless such contamination is authorized under a permit issued by the Agency.

VII. COMPLIANCE WITH SECTION 39(i) OF THE ACT

 - e. Recordkeeping plan
4. Surface water control plan
5. Closure plan
6. Post-closure maintenance plan
7. Proof of current property ownership, such as a copy of the current recorded deed of title

IX. PROOF OF NOTIFICATION OF PUBLIC OFFICIALS

Pursuant to 35 Ill. Adm. Code 1100.301, permit applicants must notify the persons listed below of the request for a permit and submit proof of the notification as a part of this application. Form LPC-PA26 may be used to provide the required notifications. Notifications must be mailed on or before the date this application is filed with the Illinois EPA. As part of this application, include a copy of each notification and a list of those persons to whom it was sent, or copies of completed notifications identifying the recipients.

1. The State's Attorney of the county in which the facility is located;
2. The Chairman of the County Board of the county in which the facility is located;
3. Each member of the General Assembly from legislative districts in which the facility is located; and
4. The Clerk of each municipality located within three miles of the facility.

X. SIGNATURES

All applications must be signed by the site owner(s) and site operator(s), or their duly authorized representatives. The following persons are considered duly authorized representatives of the following owners or operators:

1. For a corporation – a principal executive officer of at least the level of vice-president;
2. For a partnership – a general partner;
3. For a sole proprietorship – the sole proprietor;
4. For a municipality, state, federal, or other public agency – the head of the agency or a ranking elected official;
5. For a member-managed limited liability company – a member;
For a manager-managed limited liability company – a manager or a member; or
6. Another person authorized by one of the persons listed in items 1 through 5 above to sign this application on behalf of an owner or operator. Written proof of such authorization must be submitted with this application.

Certification Statement

I certify under penalty of law that, to the best of my knowledge and belief, no waste or construction or demolition debris other than clean construction or demolition debris will be disposed of or used as fill material at the site for which this application is submitted.

Any person who knowingly makes a false, fictitious, or fraudulent material statement, orally or in writing, to the Illinois EPA commits a Class 4 felony. A second or subsequent offense after conviction is a Class 3 felony. (415 ILCS 5/44(h))
