I. Introduction

Inmar submits this Drug Take-Back Program Plan ('Plan") for the Drug Take-Back Act in compliance with the State of Illinois Compiled Statutes, 410 ILCS 720/. All capitalized terms not otherwise defined shall have the same meaning as in the Statutes.

Inmar's Drug Take-Back Program Plan will provide a comprehensive Drug Take-Back Program that will include compliant Collection Methods supported by outreach and education to increase Consumer awareness and participation. In compliance with 410 ILCS 720/25(i), The Drug Take-Back Program provide for the collection, transportation, and disposal of Covered Drugs on an ongoing, year-round basis and provide access for residents across the State. The Program will be funded by participating Covered Manufacturers and Covered Manufacturers represented by this Plan shall pay all administrative and operational costs and fees associated with the Drug Take-Back Program, pursuant to subsection (a) of Section 55 of the Drug Take-Back Act. The program will also provide reporting on collection metrics and results of Consumer education and outreach campaigns.

Some of the highlights of the proposed Plan are as follows.

- Collection Receptacle Service: Turn-key program with DEA- and DOT-compliant processes and materials
- Mail-Back Services: Available by request via a website or toll-free telephone number
- **Education & Outreach:** Strategic deployment of Inmar's media assets and expertise, as well as school relationships to drive program awareness and participation
- Annual Reporting: Insight into required collection and outreach metrics

II. Definitions

This Plan uses and incorporates the definitions from the Statutes. Additional definitions have been included that are not defined in the Statutes but which help to clarify Inmar's intent in proposing this Stewardship Plan. All defined terms are capitalized in the Plan.

Agency means the Environmental Protection Agency.

Authorized Collector means any of the following who elect to collect Covered Drugs through participation in a Drug Take-Back Program:

- 1. A person who is registered with the United States Drug Enforcement Administration to collect controlled substances for the purpose of destruction;
- 2. A law enforcement agency;
- 3. A unit of local government working in conjunction with a law enforcement agency; or
- 4. A household waste drop-off point or one-day household waste collection event, as those terms are defined in Section 22.55 of Environmental Protection Act

Collection Site means the location where an authorized collector collects Covered Drugs as part of a Drug Take-Back Program.

Consumer means a person who possesses a Covered Drug for personal use or for the use of a member of the person's household.

Collection Receptacle means a metal receptacle into which Consumers deposit Unwanted Covered



Drugs and which meets the requirements of 21 CFR Section 1317.

Collection System is Inmar's term for the Collection Method that utilizes permanent Collection Receptacles at fixed locations.

Collection Method means one of the three Collection types (Collection Receptacle, Mail-Back, or Event) authorized for collection and disposal of Covered Drugs by the DEA under 21 CFR Section 1317.

Container means the cardboard box which both supports the Inner Liner inside the Collection Receptacle during drug collection and becomes the outer shipping package when the Inner Liner is full and/or removed from the Collection Receptacle.

Convenience Standard means the standard set forth in 410 ILCS 720/25(j) which dictates the number of Collection Sites required per county.

Covered Drug means a drug, legend drug, nonlegend drug, brand name drug, or generic drug. "Covered drug" does not include: (1) a dietary supplement as defined by 21 U.S.C. 321 (ff); (2) drugs that are defined as Schedule I controlled substances under the Illinois Controlled Substances Act or the federal Controlled Substances Act; (3) personal care products, including, but not limited to, cosmetics, shampoos, sunscreens, lip balms, toothpastes, and antiperspirants, that are regulated as both cosmetics and nonprescription drugs under the federal Food, Drug, and Cosmetic Act, 21 U.S.C. 301; (4) drugs for which manufacturers provide a pharmaceutical product stewardship or drug take-back program as part of a federal managed risk evaluation and mitigation strategy under 21 U.S.C. 355-1; (5) biological products, as defined by 42 U.S.C. 262(i)(l); (6) drugs that are administered in a clinical setting; (7)emptied injector products or emptied medical devices and their component parts or accessories; (8) needles or sharps; (9) pet pesticide products contained in pet collars, powders, shampoos, topical applications, or other forms; (10) dialysate drugs or other saline solutions required to perform kidney dialysis; (11) drugs sold at retail as a unit dose package; or (12) homeopathic drugs.

Covered Manufacturer means a manufacturer of a Covered Drug that is sold or offered for sale in Illinois.

DEA means the U.S. Drug Enforcement Administration.

DEA Rule means the DEA Final Rule, "Disposal of Controlled Substances," 79 Fed. Reg. 53520 et seq. adopted on September 9, 2014, and codified at 21 CFR 1317.

Director means the Director of the Environmental Health Division.

DOT means the U.S. Department of Transportation.

Drop-door means the door on the Collection Receptacle where Unwanted Covered Drugs are deposited by Consumers.

Drug has the same meaning as defined in Section 2.4 of the Illinois Food, Drug, and Cosmetic Act.

Drug Take-Back Program means a program implemented under this Act by a manufacturer program operator for the collection, transportation, and disposal of Drugs.

Drug Take-Back Program Plan means a plan for the collection, transportation, and disposal of Unwanted Covered Drugs to meet the requirements of a Drug Take-Back Program under Section 25 of the Drug Take-Back Act.

Generic Drug means a Drug determined to be therapeutically equivalent to a brand name Drug by the United States Food and Drug Administration and that is available for substitution in Illinois in accordance with the Illinois Food, Drug, and Cosmetic Act and the Pharmacy Practice Act.

Legend Drug has the same meaning as defined in Section 3.23 of the Illinois Food, Drug, and Cosmetic Act.

Inhaler Mail-Back Envelope means a pre-paid, pre-addressed envelope for the collection and disposal of inhalers.

Inmar Plan means the Drug Take-back Program Plan presented in this submittal.

Inner Liner means the liner placed inside the Container which meets the requirements of 21 CFR Section 1317.60.



Liner Kit is a set of three (3) pre-labeled and pre-paid cardboard box Containers, liquid barriers, and serialized, puncture-resistant Inner Liners.

Law Enforcement Agency or LEA is a Federal, State, tribal, or local law enforcement office or agency. **Manufacturer Program Operator (or Program Operator)** means a Covered Manufacturer, a group of Covered Manufacturers, or an entity acting on behalf of a Covered Manufacturer or group of Covered Manufacturers, that implements a Drug Take-Back Program.

Mail-Back Distribution Site means a location at which Consumers may obtain Mailers at no charge and which is provided by Inmar to meet the Service Convenience Goals established in the Ordinance. **Mail-Back Services** means a Collection Method for the return of Unwanted Covered Drugs from Consumers utilizing prepaid and pre-addressed Mailers.

Mail-Back Starter Kit means 20 Standard Mail-Back Envelopes with a visual reorder trigger, with instructions to Standard Mail-Back Distribution Sites on how to reorder additional Mail-Back Starter Kits.

Mailer is Inmar's generic term used to refer to all pre-paid, pre-addressed Standard and Inhaler Mail Back Envelopes.

Medical Practitioner has the same meaning as defined in Section 3.23 of the Illinois Food, Drug, and Cosmetic Act.

Nonlegend Drug means a drug that does not require dispensing by prescription and which is not restricted to use by practitioners only.

Person means any individual, partnership, co-partnership, firm, company, limited liability company, corporation, association, joint stock company, trust, estate, political subdivision, State agency, or any other legal entity, or their legal representative, agent, or assign.

Pharmacy has the meaning provided in Section 3 of the Pharmacy Practice Act. A "pharmacy" is not a Covered Manufacturer.

Potential Authorized Collector means a person who is eligible to be an Authorized Collector by participating in a Drug Take-Back Program.

Prescription Drug has the same meaning as defined in Section 2.37 of the Illinois Food, Drug, and Cosmetic Act.

Packaged Container means the full Inner Liner used in the Collection Receptacle, after it is removed, secured within the Container, prepared, and sealed for transportation to a DEA Reverse Distributor. **Program Year** means a calendar year, except that the first program year is from January 1, 2024 through December 31, 2024.

Proprietary Information means information that is: (1) submitted under this Act; (2) a trade secret or commercial or financial information that is privileged or confidential and is identified as such by the person providing the information; and (3) not required to be disclosed under any other law, rule, or regulation affecting a Covered Drug, Covered Drug, or Pharmacy.

Standard Mail-Back Envelope means a prepaid and pre-addressed Mail-Back Envelope for the collection and disposal of all Unwanted Covered Drugs except for those dispensed in an inhaler. **Unwanted Covered Drug** means any Covered Drug that the Consumer has discarded or intends to discard.



III. Contact Information

A list of Covered Manufacturers who agreed to participate in Inmar's Drug Take-Back Plan in the State of Illinois is provided in Appendix A. These Covered Manufacturers will pay all administrative and operational costs and fees associated with the Drug Take-Back Program, pursuant to subsection (a) of Section 55 of the Drug Take-Back Act.

IV. Collection System

A. Potential Authorized Collectors

Appendix B includes a list of Potential Authorized Collectors that were notified at least 120 days prior to this proposal being submitted as per 410 ILCS 720/25(a).

Inmar reached out to Retail Pharmacies, Law Enforcement Agencies, Long Term Care Facilities, and other locations as required by the Drug Take-Back Act that are eligible to become a Collection Site. These locations meet the requirements set forth by the Drug Take-Back Act, The Controlled Substances Act, 21 USC SS 801-971 and 21 CFR SS 1317; United States Department of Transportation Hazardous Materials Regulation, 49 CFR parts 100-185; Illinois Board of Pharmacy, and all applicable state and federal laws. Initially, letters were mailed to these Potential Authorized Collectors then follow up was made either by phone, email, or both.

Inmar attended relevant conferences to reach out to local representatives to build relationships and help provide knowledge about the Program.

- Illinois Association of Chiefs of Police "ILACP" Conference to discuss with the attendees Inmar's intent to become an approved Manufacturer Program Operator and how we could assist them in becoming a Collection Site.
- Illinois Recycling Association and Illinois Recycling Foundation Conference Inmar
 presented information about the Program requirements, helped answer questions
 concerning regulations and how the Program would work. Inmar also provided contact
 information for attendees to reach out with follow-up questions if needed.

No later than 30 days after a Potential Authorized Collector expresses interest in participating, Inmar commences good faith negotiations and enters into agreements. No later than 90 days, once the agreement is signed, the Authorized Collector is included in the program as per 410 ILCS 720/25(d). These initiatives are ongoing and will continue until the Convenience Standard is met.



B. Collection Sites

Pursuant to 410 ILCS 720/25(j), Inmar will seek to establish a minimum of one Collection Site per county with one additional Collection Site for every 50,0000 county residents, provided that there are enough Potential Authorized Collectors offering to participate in the Drug Take-Back Program.


The following process will continue until Inmar has secured the required number of Collection Sites to meet the standards set forth in 410 ILCS 720/25(j).

- 1. Continue working with all Potential Authorized Collectors that have expressed interest to secure agreements, establish Collection Sites, and install Collection Receptacles
- 2. Continue to reach out to Potential Authorized Collectors who have not responded regarding a willingness to participate in the Illinois Drug Take-Back Program
- Consult with county authorities to determine the role that mail-back distribution locations or periodic collection events will have in the Drug Take-Back Program per 410 ILCS 720/25(k)
- 4. Inmar will continue to solicit Potential Authorized Collectors and evaluate the need annually for Mail-Back Distribution Sites or periodic collection events based on population growth

Appendix C is the list of Authorized Collectors that have agreed to become a Collection Site. These locations will accept all Covered Drugs from Consumers during the hours that the location used as

a Collection Site is normally open for business to the public as required by 410 ILCS 720/25(f). They also comply with all State and federal laws and regulations governing the collection, storage, and disposal of Covered Drugs, including United States Drug Enforcement Administration regulations as required in 410 ILCS 720/15(h).

The map to the right demonstrates the 245 Collection Sites Inmar has secured so far across the State. The red pin drops are each of the Collection Sites with which Inmar has signed agreements and the blue mark is the only location that requested to be a Mail-Back Distribution Site when we discussed becoming a Collection Site. More Mail-Back Distribution Sites will be added once discussions with county authorities have been completed.





C. Collection Receptacle Specifications and Design

Inmar's Collection Receptacle is made in the USA and designed for excellence. Produced from 16 gauge cold-rolled steel, and with an easy-to-use, Americans with Disabilities Act (ADA)-compliant drop-box design, Consumers can easily drop unused medications through the Drop-door and into the shippable Container with Inner Liner inside. The Container is a 275 lb rated box with a 6 mil, DEA-compliant liner.

There are several unique features that enhance the effectiveness and security of the Inmar Collection Receptacle. For example, the top of the Collection Receptacle is sloped, limiting the ability to stack items on top. In addition, the drop slot features an extended metal Drop-door that lowers into the Container to detect when product capacity is reached. When the Drop-door encounters resistance within the Collection Receptacle, it is an indication that it is time to change the Container. This manual capacity indicator eliminates the need to change batteries and/or sacrifice the location of the Collection Receptacle to be in proximity to an electrical outlet. Lastly, the Container access door is reversible to allow for convenient placement in any appropriate location.

For any retail or hospital Pharmacy participating as an Authorized Collector, the Collection Receptacle must be installed in the line of sight of the Pharmacy and bolted to the floor or a permanent fixture as required by DEA. The Inmar Collection Receptacle has pre-drilled holes in the bottom for easier installation. It also features a 4-point locking system with steel projections in two center locations and the top and bottom of the door that are activated when locked for strengthened security. Top and bottom deadbolt locations are hidden from the outside to prevent break-ins.

The Inmar Collection Receptacle will have signage that communicates what is and is not allowed to be placed inside. Appendix E contains an image of a Collection Receptacle as well as the associated signage.

Inmar's DEA and ADA-compliant Collection Receptacle is sent to the Authorized Collector along with enough supplies for 3 returns. Supplies include:

- Pre-addressed, pre-paid serialized Containers
- Serialized Inner Liners to protect against puncture and provide a liquid barrier
- Zip ties to seal each Inner Liner compliantly
- Absorbent pad for placement in the bottom of the Inner Liner bag

Standard Self-Service Returns

Inmar will train Authorized Collectors to service the Containers on their own to allow for expedited servicing as desired. The steps to service a Container are fast, efficient, and DEA-compliant. Inmar will provide Authorized Collectors with training materials including step-by-step instructions for tracking, sealing, replacing, and shipping collection Containers. Pursuant to 410 ILCS 720/25(g), this return model allows Collection Sites to service Collection Receptacles as often as necessary to avoid reaching capacity. The process for Authorized Collectors, once a Collection Receptacle is installed is as follows:



- Authorized Collector receives the Liner Kit
- Authorized Collector staff constructs the Container with Inner Liner, inserts and securely locks the Collection Receptacle
- Authorized Collector team unlocks the Collection Receptacle Drop-door to enable Consumer use
- Installation date of Inner Liner is documented and witnessed by the Authorized Collector's designated staff members on a tracking sheet
- Once Collection Receptacle is full, two Authorized Collector staff will jointly open the Collection Receptacle
- Container and Inner Liner are removed and documented on the tracking sheet
- Container is packaged (Inner Liner is zip-tied, outer box is taped) to be compliant with all DOT Hazardous Materials Statutes
- The sealed Inner Liner will not be opened, x-rayed, analyzed, or otherwise penetrated
- Replacement Container and Inner Liner is constructed, inserted, secured into Collection Receptacle and documented on the tracking sheet
- Authorized Collector staff contacts FedEx for pickup of Packaged Container for shipping to authorized Disposal Facility for destruction

The Authorized Collector will be responsible for packaging the Container and Inner Liner for shipment and contacting FedEx for pickup. Typically, FedEx will respond within 48 hours of request by phone. Authorized Collectors utilizing the FedEx shipping portal are able to request in the "Notes" field a specific pick-up time.

Inmar's training includes documentation that details the steps required to schedule FedEx pickups of the full Containers. Inmar conveys this training both in written and oral format. Inmar has established several processes for potential issues to be mitigated. Aside from visual inspection when locking and unlocking the Collection Receptacle for use during operating hours, the Authorized Collector's staff are provided with the following resources should they experience issues with the Collection Receptacle:

- Email the take-back@inmar.com inbox, which is monitored by a team of full-time workers, and the issues can be quickly triaged and handled. This inbox is the quickest and most effective way for us to respond to any issues with Collection Receptacle
- Authorized Collectors can also call 1-800-350-0396, option 5 for urgent issues

Auto-Replenishment of Collection Receptacle Supplies

The supplies used to collect and transport Covered Drugs are provided in automatically-replenished Liner Kits of three Containers. Each Liner Kit includes: pre-labeled and pre-paid cardboard box Containers, liquid barriers, and serialized, puncture-resistant Inner Liners. The Liner Kits, when packaged with the interior components, are approximately 6 inches thick. The Container is cinched tightly around the inner components, which makes for a very easy-to-store kit. Liner Kits can be stored behind the counter, behind a door, or under or behind a desk, with no ongoing maintenance required.

Upon receipt of the Packaged Container at the reverse distributor, an electronic raw data file via SSH File Transfer Protocol (SFTP) with the weight, serialized barcoded label information, and



tracking information is passed to Inmar. This information is then received and entered into an Order Management log and Inbound Receipts log. The system tracks when the second of the three Containers is received at the reverse distributor. Then initiates a reorder trigger for the next Liner Kit to be shipped. The delivery of the Liner Kits occurs according to the following schedule:

- After the second full Container is received, the new Liner Kit would be received by the Collection Site within 14 days. This timeline allows Inmar to complete the processes described above where the SFTP file is logged and a reorder trigger is initiated
- If a Collection Site contacts Inmar requesting an additional Liner Kit for any reason outside the normal process described above, the Liner Kit would be received by the Collection Site within 7 days. Turnaround of requests for additional Liner Kits outside the auto-replenishment process are quicker because there is no SFTP file, logging, etc.

It should be noted that only after the second Container is received from a Collection Site will a new Liner Kit be sent. Auto replenishment reduces the amount of inventory maintained at the Collection Site while maintaining sufficient supplies to keep the Collection Receptacle continuously operable.

D. Transportation and Disposal

Collection Receptacle Packaged Containers will be sent using Inmar's DOT Special Permit #20499 from the authorized Collector via FedEx to Inmar's Service Provider, a licensed DEA Reverse Distributor-Collector. All mailers will be sent via USPS to Inmar's Service Provider that will record the following information upon receipt of every individual kiosk container (including inner liner) and all mail-back envelopes and packages:

- Date received
- Serialized barcode label information
- FedEx Tracking information (kiosk containers only)
- Weight
- Date transported to disposal facility
- Disposal date
- Manifest number (if applicable).

All information recorded will be transferred back to Inmar on a daily basis as part of the electronic raw data file via SSH File Transfer Protocol (SFTP). Any discrepancies observed by the service provider will be recorded on discrepancy reports to prompt any corrective action.

Inmar's service providers operate in full compliance with DEA § 1317.75(c) which prohibits handling substances after they have been deposited into a Collection Receptacle.

All Unwanted Covered Drugs shipped directly to Inmar's Service Providers will be transported by common carrier to the appropriate disposal facility to be incinerated quickly, securely, efficiently, and in accordance with all DEA requirements. Inmar's Service Providers will be responsible for all DEA Form 41 record keeping requirements. Please refer to the table below for the contracted disposal locations.



Pursuant to 410 ILCS 720/25(g)(1-3), all Inmar's service providers will comply with all local, state and federal laws and regulations surrounding the transportation and disposal of Unwanted Covered Drugs including the United Stated DEA regulations. Contact information and registration information is listed in the table below.



Tracking is well-documented as evidenced by the serialization tracking forms referenced below. This form must be completed and witnessed by two Authorized Collector employees, which assures compliance and safety across the program, and internally by both the Program Operator and the Authorized Collector.



All Service Providers involved in collection services, transportation, or disposal will comply with The Drug Take-Back Act, The Controlled Substances Act, 21 USC SS 801-971 and 21 CFR SS 1317; United States Department of Transportation Hazardous Materials Regulation, 49 CFR parts 100-185; Board of Pharmacy, and all applicable state and federal laws.

Service Standards

Inmar has a long standing contractual relationship with FedEx and therefore has multiple internal and external contacts. Inmar's procurement and operations teams have direct relationships with personnel at the FedEx corporate office. Should an issue arise with the standard 48 hour service level agreement, these contacts will be leveraged daily for mitigation of further issues as well as any needed general support.

Inmar will periodically monitor all Container FedEx shipment tracking numbers from Pharmacy locations to the designated reverse distributor. Typically, any Packaged Container that is shipped has a 3-5 day ground shipment time frame from the moment it is scanned by a FedEx driver to the delivery point. Should a Packaged Container not arrive at our reverse distributor within an acceptable time frame (ten days), the Operations team will do the following:

- Reach out to site host to determine when Packaged Container was picked up
- Track liner via tracking ID portal at FedEx.com
- Contact regional rep for FedEx to investigate the root cause of delay
- Investigate the location of Packaged Container and identify updated arrival date at reverse distributor site

Should it be determined that the container has been lost in transit, or, there is a suspected diversion incident that has taken place, Inmar's compliance team will make the appropriate notification to the DEA within (1) days. Should the Inmar team not be able to locate the container



after the container has been in transit for 10 days (the destruction facility has no evidence of receipt, and the FedEx contact is indicating that the container was lost during transport), the Inmar compliance team will make the appropriate notification to the DEA within (1) days.

E. Mail-Back Services

Inmar will provide prepaid and pre-addressed Mailers, free of charge, to all Consumers including homeless, homebound, or disabled individuals. Mailers will be provided at Mail-Back Distribution Sites that are set up after consultation with the county authorities, and will also be available directly from Inmar via the program website and toll-free telephone number.

Inmar will offer Mail-Back Services at multiple retail and healthcare locations throughout the state. In locations where Inmar needs to offer Mail-Back Services to supplement the requirements for the Convenience Standard, our plan is simple and easily repeated. Unless otherwise requested by Collection Sites, we will distribute Mailers only at locations that are non-Collection Sites, or sites not hosting Collection Receptacles.

Once a location has been accepted as a Mail-Back Distribution Site, Inmar will send a stack of prepaid, pre-addressed Mailers to that location as a Mail-Back Starter Kit. Mailers will accept all Unwanted Covered Drugs, including pills, creams, and liquids, and schedule II-V controlled substances. However, inhalers will require the use of different Mailers (described below) and will not be included in the Starter Kit. The Starter Kit will include 20 Standard Mail-Back Envelopes sent to each location. Inmar will track the unique identifier for all Mailers sent to each location for fulfillment and logistical purposes. Inmar will add a visual reorder trigger in the box of Mailers. Once the location gets to the reorder trigger in the box, the visual reorder trigger will instruct the location to email Inmar for another kit. This service model ensures that there is no 'down time' at the site for Mailers.

Inmar is committed to providing all Pharmacies an option to supply their customers with information regarding Mail-Back Service options. Inmar can provide Pharmacies with educational material that can be handed out to Consumers that may need access to this service. The educational materials will instruct them to either call or visit the Program website to locate the nearest Collection Site or request a Mailer. Additionally, we will reach out to Pharmacies filling prescriptions by mail to include the cards for the same options.

Additionally, State residents will be able to request up to three Mailers at a time via the Program website or toll-free telephone number. Once Inmar receives the request it will be processed and sent out within ten business days.

Both the Standard Mail-Back Envelope and Inhaler Mail-Back Envelope will meet Covered Drug requirements under § 1317.70(c):


- Preaddressed, postage paid
- Nondescript, and do not indicate what may be inside
- Waterproof, tamper-evident, tear-resistant, and sealable
- Contain a unique ID number that allows for tracking
- Include instructions for the user that indicate the process for mailing the package,



substances that can be sent, notice that packages can only be mailed in the US customs territory, and notice that the only packages provided by the Authorized Collector will be accepted

No personally identifiable information will be required


Both Envelopes are white in color with a gray interior and are 7" x 10". The Envelopes include a 3" perforated lip security seal. A sample Standard Mail-Back Envelope is shown below.

Consumers will be able to request one Inhaler Envelope at a time via the Program website or toll-free telephone number. Once Inmar receives the Inhaler request it will be processed and sent out within ten business days.

Mail-Back Instructions

Mail-Back instructions to Consumers for Mailers are provided in Appendix E.

Mail-Back Envelope Tracking

Mailers distributed by authorized Mail-Back Distribution Sites will be tracked in a method similar to the Collection Receptacle collection Containers. Mailers will have a unique, serialized identification number. Once the Mailer arrives at the destruction facility, the serial number will be noted before final disposition.

Mailers distributed directly to Consumers via request from the website or toll-free telephone number will be tracked by Inmar when sent to Consumers and tracked at the destruction facility when they are returned. This tracking process will allow Inmar to report the number of Mailers distributed and returned in the Annual Report provided to the Agency, as required.

F. Collection Events

Based upon the consultation with the county authority, Inmar will hold periodic collection events where there are underserved areas not serviced by either Collection Receptacles or Mail-Back Service. Collection events will be held in accordance with the applicable regulations and protocols of the Drug Enforcement Administration of the United States Department of Justice. Below is a description for planning, hosting, staffing, and promoting collection events.



Location Planning and Scheduling

Locations of collection events will be determined based on the counties that are most in need while taking into consideration their access to Collection Receptacle and Mail-Back Distribution Sites. Once the area of need is identified, Inmar will explore locations where it is feasible to host a collection event. Most often this will be at a Law Enforcement Agency (LEA) or a satellite LEA location nearest the target area. However, Inmar has relationships with many other organizations that may be interested in hosting a collection event. We may determine these locations to be even more convenient for Consumers if they are places that the population is already visiting on a regular basis or can accommodate unique situations such as drive-through collection. Additionally, Inmar will consider the willingness or availability for LEA's to provide oversight at the selected location. Inmar will ensure any selected locations meet all applicable laws and regulations.

Event Staffing and Oversight

In compliance with DEA 1317.65(a)-(b), Inmar will ensure that at least one Law Enforcement Agency personnel is present at each collection event. LEA's will be responsible for maintaining any records of removal, storage, or destruction of the controlled substances collected in a manner that is consistent with that agency's recordkeeping requirements for illicit controlled substances evidence. Inmar also keeps a record on its own tracking sheet that includes the tracking number, liner #, tamper tag number, and final weight as a backup. In addition, any controlled substances collected at collection events will be stored and transferred for destruction in a manner that prevents the diversion of these substances.

Inmar will provide adequate staffing and resources to assist LEAs with logistics, coordination and/or other needs during the event. It will be Inmar's responsibility to coordinate with the City and LEAs to ensure compliance with all applicable laws and regulations. Inmar will work with the designated LEA to ensure that all material collected is placed in compliant Containers and any material that does not meet legal requirements is rejected.

Execution Procedures

As required by DEA § 1317.65, Law Enforcement Officers employed and authorized by the LEA will maintain control and custody of the collected substances from the time the substances are collected from the Consumer until secure transfer, storage, or destruction of the controlled substances has occurred.

Inmar will ensure that only Consumers dispose of approved Covered Drugs to law enforcement during the collection event. No other person will handle the controlled substances at any time.

At the conclusion of collection events, Inmar will work with LEAs to ensure that the collected materials are properly weighed, packaged, secured, and shipped to Inmar's designated destruction partner in compliance with all applicable laws. As is standard practice for Collection Receptacle returns under this Plan, Containers will be tracked via their unique identifiers from shipment location to the designated destruction facility.

Inmar will make certain that both Inmar and LEAs keep a record of the following information after the transfer of controlled substances as a result of any collection events:

- Unique identification number of the sealed Inner Liner transferred
- Size of the sealed Inner Liner transferred (e.g., 35-gallon)
- Name, address, and registration number of the reverse distributor to whom the controlled



substances were transferred

 Copy of the tracking sheet that includes the tracking number, Inner Liner number, tamper tag number and final weight for documentation purposes

Collection Event Promotion

Inmar will work with the local Law Enforcement Agency or other designated location on any advertisement, promotion, set-up and tear down of the event, and community engagement. Inmar will provide promotion for the Collection Event, including local advertising, LEA (or other location organization), social media, and press releases to local news outlets. During the time of the event, Inmar will provide educational marketing materials to instruct Consumers where to find a Collection Receptacle in their area.

Collection Event Reporting

Pursuant to 410 ILCS 720/50, Inmar will include in the Annual Report the following information:

- Date and location of each collection event held
- The amount, by weight, of drugs collected at each collection event
- The amount of liners collected from each event

G. Program Operator Requirements

Policies and Procedures

Inmar will ensure that it acts in compliance with all applicable laws, rules, and regulations related to the collection, handling, and disposal of Covered Drugs and as specified by the Plan requirements and require, by contract, that Service Providers and Authorized Collectors are also compliant with all laws, regulations, and legal requirements.

Inmar will specifically require Authorized Collectors and service providers involved in collection services, transportation, or disposal to comply with The Drug Take-Back Act and regulation, The Controlled Substances Act, 21 USC SS 801-971 and 21 CFR SS 1317; United States Department of Transportation Hazardous Materials Regulation, 49 CFR parts 100-185; Board of Pharmacy, and all applicable state and federal laws.

Security of Patient Information

Inmar provides significant training to our participating Authorized Collectors and strictly follows the DEA regulations for the proper handling of the Collection Receptacle and Inner Liners. This begins with the training of the Authorized Collector in the compliant operation of the Collection Receptacle and proper preparation, removal, and packaging of the Container. It also involves the training of staff that may come into contact with the Packaged Containers to ensure proper handling. Inmar strictly complies with state and federal statutes and regulations, including but not limited to the DEA regulations cited below.

According to the DEA - As provided in §§ 1317.60(c) and 1317.70(f), Inner Liners shall be sealed immediately upon removal from the Collection Receptacle; sealed Inner Liners and Standard Mail-Back Envelopes shall not be opened, x-rayed, analyzed, or otherwise penetrated. Accordingly, their contents shall not be sorted or inventoried subsequent to being placed into Collection



Receptacle or Mailers. To clarify this, § 1317.75(c) was modified to add the prohibition against individually handling substances after they have been deposited into the Collection Receptacle.

Inmar, contracted service providers, and Authorized Collectors will comply with all regulations regarding the protection of patient privacy and will be HIPAA and Protected Healthcare Information (PHI) compliant. Any and all patient information on drug packaging will be promptly destroyed in the unlikely event of exposure.

Program Promotion

Inmar will promote the program by providing Consumers, Pharmacies, and other entities with education and informational materials as required under 410 ILCS 720/45. Greater details are below in Section I: Program Promotion. Inmar uses service providers that are industry leaders in the pharmaceutical waste transportation and disposal industry, some of which are Waste to Energy facilities that provide energy back to communities. DEA § 1317.75(c) prohibits handling substances after they have been deposited into a Collection Receptacle. For this reason, Inmar is unable to separate and recycle drug packaging. Inmar will, however, execute educational programs, as outlined in Section I, below to encourage Consumers to separate Unwanted Covered Drugs from their packaging and recycle the packaging prior to disposal. Even though regulations prevent us from recycling drug packaging, Inmar has an interest in reducing waste and improving our environment. Through our Rx Returns and related business lines, Inmar has saved over 20,000 barrels of oil, recovered over 11,000 megawatts of clean energy, and powered over 900 homes in the past two years alone. We will continue to look for opportunities to expand our eco-friendly efforts in the State.

V. Changes or Modifications

Inmar, once approved, will maintain records for five years of any changes to the approved Take-Back Program Plan. These include, but are not limited to, changes in:

- 1. Participating Covered Manufacturers;
- 2. Collection Methods;
- 3. Collection Sites; or
- 4. Contact information for Program Operator or Authorized Collectors

VI. Program Promotion

Inmar will execute a comprehensive and measurable public education and outreach strategy to drive awareness of the Stewardship Plan and maximize participation pursuant to 410 ILCS 720/45. In addition to preventative education, Inmar's strategy is designed to ensure that where and how to return Covered Drugs is widely understood by Illinois Consumers and Authorized Collectors.

Pursuant to 410 ILCS 720/45 1-6, the individual components of Inmar's public outreach strategy are detailed below. Across all tactics and key messages will include, but not be limited to, the following:

- 1. Promoting the proper management of drugs through a Drug Take-Back Program
- 2. Discouraging Consumers from disposing of drugs in household waste, sewers, or septic systems
- 3. Promoting the use of the Drug Take-Back Program so that where and how to return Covered Drugs is readily understandable to Consumers



- 4. Maintaining a toll-free telephone number and website publicizing collection options and collection sites, and discouraging improper disposal practices for Covered Drugs, such as disposal in household waste, sewers, or septic systems
- 5. Preparing and distributing to program collection sites, for dissemination to residents, the educational and outreach materials. The materials will use plain language and explanatory images to make collection services and discourage disposal practices readily understandable by residents, including residents with limited English proficiency
- 6. Promotional materials prepared and distributed in conjunction with an approved Drug Take-Back Program will not be used to promote in-home disposal products of any kind, including, but not limited to, in-home disposal products of Authorized Collectors participating in a Drug Take-Back Program

Inmar will coordinate to ensure that Consumers clearly understand the logistics, safety, and educational components of the Program. Inmar will coordinate educational outreach with any other Program Operators to ensure consistent messaging regarding the geographic location of Collection Sites, safe disposal of medication, statistics regarding the dangers of pharmaceutical waste in the waste-stream, drug abuse statistics, and other program advocacy, means of Envelope distribution, and any other pertinent information related to the success of the program. Inmar will coordinate with other Program Operators to ensure consistent messaging among the types of educational outreach.

Website

Inmar will provide a neutrally branded, mobile-optimized website that will publicize collection options and educate all Consumers, including individuals with limited English proficiency, on proper disposal practices. Inmar will use enhanced search engine optimization to ensure easy location and access.

Specifically, the website will:

- Allow Consumers to contact Inmar
- Allow Consumers to find the nearest Collection Site or Mail-Back Distribution Site via an
 interactive map. The list of locations will be updated monthly to ensure accuracy. The location list
 will be inclusive of all Collection Receptacles located in the State including those operated by
 other Program Operators
- Allow Consumers to request prepaid Mail-Back Envelopes
- Clearly indicate what substances are and are not accepted.
- Include educational and outreach materials safe storage and disposal of Covered Drugs
- Feature links to Consumer Drug Take-Back social media pages for more useful content

Potential Authorized Collectors interested in participating in the Program will be able to request more information through the website. In addition, participating Authorized Collectors will have access to resources for compliant Collection Receptacle management (including installation, tracking, and shipping) and will be able to request on-site Collection Receptacle maintenance and support.

Toll-free Telephone Number

Coordinating with other Program Operators as needed to comply with 410 ILCS 720/45, Inmar will operate a toll-free call center that interested parties can call to learn more about the Program, and drug disposal best practices. Consumers will also be able to request information about the nearest Collection Site or Mail-Back Distribution Site, request that a prepaid Mailer be sent to them, or acquire information about other collection processes. The call center is operated with live operators and will be staffed with a third party service to assist with live translation with the recommended languages as requested by IL



EPA. All operators are trained to assist and answer questions related to any and all questions related to the Stewardship Plan operation including but not limited to Authorized Collector support and service requests.

Callers with medical emergencies will be directed to call 911. Patients with medication-related questions will be directed to contact their health care provider(s).

Authorized Collectors will also be able to call the Toll-free telephone Number to request on-site Collection Receptacle maintenance and support.

Coordination with Other Approved Plans

In accordance with 410 ILCS 720/45, Inmar will work with any other approved Program Operators to ensure that Consumers can easily identify, understand and access the services provided by all Drug Take-Back Programs operating under a IL EPA approved plan. This includes the development of a neutrally branded Program website. Inmar will collaborate with other approved Program Operators to identify a Service Provider who can provide these services. Inmar will also work with other approved Program Operators to establish a toll-free telephone number. Inmar will work with other approved Program Operators to establish a common logo for statewide Drug Take-Back Programs that can be included on the website, outreach and educational materials, and Collection Receptacles.

Upon alignment of coordination, Inmar will request approval from IL EPA in writing as to the nature of these collaborative efforts no later than 30 days after approval of multiple program Plans.

VII. Annual Report

As required by 410 ILCS 720/50, Inmar will provide an annual report by April 1, 2025 and each April 1 thereafter, describing the implementation of the Drug Take-Back Program during the previous calendar year. The report will include:

- A list of the Covered Manufacturers participating in the Drug Take-Back Program during the program year;
- 2. The total amount, by weight, of Covered Drugs collected and the amount, by weight, from each Collection Method used during the program year, reported by county;
- The total amount, by weight, of Covered Drugs collected from each Collection Site during the prior year;
- 4. The following details regarding the Program's Collection System:
- 5. A list of Collection Sites, with addresses;
- 6. Collection Sites where Mailers to Program Collection Sites, for dissemination to Consumers, and education and outreach materials were made available to the public;
- 7. Dates and locations of collection events held; and
- 8. The transporters and disposal facility or facilities used to dispose of the Covered Drugs collected;
- 9. A description of the promotion, education, and public outreach activities implemented;
- 10. A description of how collected packaging was recycled to the extent feasible; and
- 11. An evaluation of the Program's effectiveness in collecting Covered Drugs during the program year and of any Program changes that have been implemented



VIII. Manufacturer Drug Take-Back Program Funding

As required in 410 ILCS 720/55, Inmar will ensure the group of Covered Manufacturers it represents with this plan will pay all administrative and operational costs associated with establishing and implementing the Drug Take-Back Program in which they participate. Such administrative and operational costs include, but are not limited to:

- 1. Collection and transportation supplies for each Collection Site;
- 2. Purchase of Collection Receptacles for each Collection Site;
- 3. Ongoing maintenance or replacement of Collection Receptacles when requested by Authorized Collectors;
- 4. Costs related to prepaid, pre addressed mail;
- 5. Compensation of Authorized Collectors, if applicable;
- 6. Operation of periodic collection events, including, but not limited to, the cost of law enforcement staff time;
- 7. Transportation of all collected Covered Drugs to final disposal;
- 8. Proper disposal of all collected Covered Drugs in compliance with State and federal laws, rules, and regulations; and
- 9. Program promotion and outreach

All costs associated with the program will be apportioned among each participating Manufacturer. Inmar uses data on Covered Drugs to inform Program costs. Data sets from Covered Drugs sold include volume estimates, relative value, comparisons to states with similar populations, and actual historical data from the state.

Neither Inmar nor any other party (Covered Manufacturer nor any Authorized Collector) will impose a charge of any kind on the general population for the purpose of recovering costs of the Drug Take-Back Program. Program services will be free to the Consumers.
