

I. Executive Summary

MED-Project IL, LLC (“MED-Project”) operates a Product Stewardship Plan for Unwanted Medicine from Households (“Plan”) in the State of Illinois (the “State”) under the Illinois Drug Take-Back Act (410 ILCS 720) (the “Law”). The Illinois Environmental Protection Agency (the “Agency”) approved MED-Project’s Plan dated June 30, 2023, on September 26, 2023 (the “Approved Plan”). This 2024 Annual Report (“Report”) describes MED-Project’s activities between January 1, 2024, and December 31, 2024 (the “Reporting Period”). All capitalized terminology not defined in this summary is derived from the Approved Plan.

Following the adoption of the Illinois Drug Take-Back Act on June 10, 2022, MED-Project began drafting a drug take-back plan and preparing to implement a drug take-back program in Illinois. As required by the Law, prior to submitting a proposed plan, MED-Project registered with the Agency as a Manufacturer Program Operator and notified Potential Authorized Collectors in Illinois of the opportunity to serve as an Authorized Collector for the proposed program in 2023. On December 11, 2023, the Agency approved the most recent modification to the plan regarding the registration status of participating Covered Manufacturers.

During the Reporting Period, MED-Project met its Plan commitments of establishing 150 Collection Sites by January 1, 2025, by operating 316 MED-Project Collection Sites and 16 Mail-Back Distribution Locations across the State and in the 17 rural counties identified by the Agency in a letter provided to MED-Project via electronic mail on September 5, 2023 (Calhoun, Clark, Gallatin, Hardin, Henderson, Jasper, Kendall, Lee, Marshall, Mason, Massac, Menard, Moultrie, Pope, Putnam, Stark, and Warren).

A. Notifications in the Reporting Period

MED-Project did not submit any change requests or notices during the Reporting Period.

B. Reporting Period Operations Overview

Throughout the Reporting Period, MED-Project began implementation of the Approved Plan according to the Post Plan Approval Implementation Timeline, discussed in Appendix C of the Approved Plan. Included in the implementation timeline is MED-Project’s establishment of Collection Sites, offering of mail-back services through the MED-Project Website and MED-Project Call Center to residents, and the launch of the education and outreach program. During the Reporting Period, MED-Project continued issuing agreements to Pharmacies and other potential Authorized Collectors. By the end of the Reporting Period, MED-Project established 316 Collection Sites and distributed Mail-Back Packages at 16 Mail-Back Distribution Locations, as well as through the MED-Project Website and Call Center. For more information about

Collection Sites and mail-back services, please see Section III of this Report. MED-Project successfully launched the Website, launched the Call Center, launched the Help Desk for potential Authorized Collectors and Collection Sites, and began distribution of printable materials and signage to participating Collection Sites. MED-Project also conducted a campaign featuring digital display, online video, and paid social media ads during the Reporting Period. MED-Project also agreed to Terms of Coordination and launched a single, neutrally branded website landing page, and a toll-free telephone number with the other approved Manufacturer Program Operator. For more information about the education and outreach program, please see Section V of this Report.

MED-Project Collection Receptacles were installed in Pharmacies, hospitals, and Law Enforcement Agencies (LEAs) that meet all local, state, and federal requirements and that executed agreements with MED-Project. Promotional materials, including signage and/or brochures, were made available upon request to participating MED-Project Collection Sites.

MED-Project provided disposal instructions to Collection Sites and provided mail-back services to residents through the MED-Project Website and Call Center. These mail-back services were available to all Illinois residents, including those who are homeless, homebound, or disabled and those who live in rural counties where access to Collection Sites may be limited. MED-Project continues to communicate with Authorized Collectors to distribute outreach materials upon request, review procedures as needed, and improve overall Program design.

As outlined in the Approved Plan, the ultimate goal of the Program is to provide residents with convenient, safe, and accessible methods to dispose of Covered Drugs.

The following sections of the Report respond to specific reporting requirements in the Law. Each section of the Report restates the corresponding Law requirements and provides the required information. All figures are rounded to the nearest tenth place.

II. Participating Covered Manufacturers and Registered Program Operator

Section 50 (a)(1): “A list of the covered manufacturers participating in the drug take-back program during the program year;”.

As required by 410 ILCS 720/60(a), MED-Project registered as a Manufacturer Program Operator for the 2024 program year prior to the beginning of the Reporting Period.

For a list of Covered Manufacturers that participated during the Reporting Period, see Appendix A; Covered Manufacturers. As provided in the Approved Plan, “[a]ny manufacturers identified in [the Plan], however, that have not separately registered with IEPA and paid the required fee pursuant to Section 60 of the Illinois Drug Takeback Act are not considered to be participating in the MED-Project Plan.” Approved Plan Section V.A.

III. Collection Method and Weight

Section 50 (a)(2): “The total amount, by weight, of covered drugs collected and the amount, by weight, from each collection method used during the program year, reported by county;”

MED-Project collected a total of 149,564.0 pounds of Unwanted Medicine through all methods during the Reporting Period.

A. Collection Sites

Section 50 (a)(3): “The total amount, by weight, of covered drugs collected from each collection site during the prior year;”

Section 50 (a)(4)(A): “A list of collection sites, with addresses;”

MED-Project collected a total of 149,332.5 pounds of Unwanted Medicine through 316 MED-Project Collection Sites that operated during the Reporting Period. For a list of MED-Project Collection Sites with addresses and weight collected, see Appendix C; MED-Project Collection Site Addresses and Collection Data.

B. Mail-Back Packages

Section 50 (a)(4)(B): *“Collection sites where mailers to program collection sites, for dissemination to consumers, and education and outreach materials were made available to the public;”*

As described in Section C of the Approved Plan, MED-Project committed to establishing Mail-Back Distribution Locations by January 1, 2026. In the Agency’s September 26, 2023, Plan approval letter, the Agency instructed that a drug take-back program may include Mail-Back Distribution Locations within a county to reach compliance with the minimum coverage requirements of the Law. To that end, MED-Project operated 16 Mail-Back Distribution locations during the Reporting Period. For a list of Mail-Back Distribution Locations see Appendix D; Mail-Back Distribution Locations.

During the Reporting Period, collected a total of 231.5 pounds of Unwanted Medicine through the return of Mail-Back Packages. MED-Project distributed Mail-Back Packages from the MED-Project Website, Call Center, and Mail-Back Distribution Locations:

- MED-Project collected a total of 74.3 pounds of Unwanted Medicine through the return of 144 Standard Mail-Back Packages.
- MED-Project collected a total of 14.0 pounds of Unwanted Medicine through the return of 23 Inhaler Mail-Back Packages.
- MED-Project collected a total of 143.1 pounds of Unwanted Medicine through the return of 82 Injector Mail-Back Packages.

C. Collection Events

Section 50 (a)(4)(C): *“Dates and locations of collection events held; and “*

No Collection Events were held during the Reporting Period.

V. Promotion, Education, and Public Outreach Activities

Section 50 (a)(5): “A description of the promotion, education, and public outreach activities implemented;”

A. Promotion Activities

MED-Project promoted the Program to residents aged 18 and over by conducting a campaign featuring digital display, online video, and paid social media ads that generated more than 17 million impressions. MED-Project also provided information through the MED-Project Website and posted information on social media sites. See Appendix G for the Media Outreach Summary. See Appendix H for organic Social Media Activity.

B. Education Activities

The MED-Project Website was developed to effectively communicate Program information to residents and allows residents to order Mail-Back Packages and find information about MED-Project Collection Site locations. The MED-Project Website is designed to be user-friendly, compatible with mobile devices, and accessible across different browsers and devices. Further, it provides translations in multiple languages through the integration of a translation tool. See Appendix I for examples of website pages. See Appendix J for website statistics.

MED-Project established the MED-Project Call Center as an additional, effective means to communicate Program information to residents aged 18 and over. The MED-Project Call Center provides assistance with ordering Mail-Back Packages, obtaining information about Collection Site locations, and requesting educational materials about the Program. The toll-free telephone number is available 24 hours a day, 7 days a week, and provides residents the option to access an automated recording in English or Spanish via an interactive voice response system. For individuals who are hearing or speech impaired, the 711 teletype service is also available. The MED-Project Call Center also provides translation services upon request with the assistance of a human representative. The MED-Project Call Center received 25 calls during the Reporting Period.

Additionally, during the Reporting Period, MED-Project coordinated with the other approved Manufacturer Program Operator to collectively implement the Program promotion requirements in 410 ILCS 720/45, launching a single toll-free number and neutral website for residents to use to contact approved Manufacturer Program Operators about the Program.

The neutral website, which launched on May 2, 2023, features information about disposal options for Covered Drugs, including an interactive map with locations where residents can access a Collection Site at a convenient location, or how to order Mail-Back Packages. See Appendix J for statistics for the neutral website. The neutrally branded, toll-free telephone number serves as a combined call center directory to distribute calls from residents to either MED-Project’s Call Center or the other Manufacturer Program Operator’s toll-free numbers, using a mechanism that divides and forwards the calls equally among the two operators.

C. Public Outreach Activities

During the Reporting Period, MED-Project launched a public service announcement (“PSA”) highlighting different disposal options available to residents. This PSA is available on the MED-Project Website and was also directed at residents through social media and online video campaigns. In addition, MED-Project promoted the Program by providing written educational materials and in-store signage to Collection Sites and other locations upon site activation or request. Written materials and in-store signage were translated into English and Spanish as printed hard copies and made available for universal translation via the MED-Project Website.

The materials use plain language and explanatory graphics to promote options for the safe collection of Unwanted Medicine, including the availability of Collection Sites and Mail-Back Packages to residents. See Appendix K for examples of written educational materials and in-store signage. See Appendix L for a list of sites that received written materials and in-store signage.

VI. Packaging Recycling

Section 50 (a)(6): *“A description of how collected packaging was recycled to the extent feasible; and”*

As discussed in Section IV.D of the Approved Plan, MED-Project has considered and evaluated options for the separation and recycling of Covered Drug packaging. Separating and recycling Covered Drug packaging collected under the Approved Plan would require the management of separate waste streams at Collection Sites: a waste stream for Covered Drug packaging and a waste stream for the Covered Drugs themselves. While Covered Drug packaging is expected to constitute a significant amount of the waste incinerated under the Approved Plan, MED-Project has concluded that separation of inner and/or outer packaging from Covered Drugs or recycling packaging would raise three significant concerns:

- Separating and recycling drug packaging could result in the disclosure of confidential patient information appearing on prescription drug packaging.
- Separating and recycling drug packaging could increase the potential of releases and leakage of Covered Drugs.
- Separating and recycling drug packaging could increase diversion risks by adding additional steps to the collection process and, because drug packaging is used in drug counterfeiting, could be a diversion target itself.

For these reasons, the Program did not provide for the separation and recycling of packaging from Covered Drugs during the Reporting Period.

VII. Effectiveness

Section 50 (a)(7): *“An evaluation of the program's effectiveness in collecting covered drugs during the program year and of any program changes that have been implemented.”*

There are many aspects of a product stewardship program that must be considered in determining the program's effectiveness. An effective product stewardship program is one that achieves substantive compliance with the objectives of its approved product stewardship plan. The Approved Plan identifies six major objectives which demonstrate effective Plan implementation. As an indication of Program effectiveness, all of these objectives were achieved during the Reporting Period by MED-Project as described in this section.

The six major Plan implementation objectives include:

1. Establishment of a collection system to provide free, convenient, and ongoing collection opportunities for Unwanted Medicine from households.
2. Collection of Unwanted Medicine from households via collection receptacles and Mail-Back Packages.
3. Establishment of a toll-free telephone number and neutral website, through coordination with the other approved Manufacturer Program Operator.
4. Provide educational materials and signage regarding the Program and the opportunities for safe disposal of Covered Drugs available to residents.
5. Implementation of paid media activities to effectively promote the Program and educate the public.
6. Payment of all costs associated with the administration and operation of the Program by participating Covered Manufacturers.

No Program changes were implemented during the Reporting Period.

Objective 1: Collection System




Figure 1: Map of Active MED-Project Collection Sites and Mail-Back Distribution Locations

Prior to the Reporting Period, MED-Project sent an Opportunity to Participate email to over 2,700 Potential Authorized Collectors in Illinois, as well as ten organizations representing members that are Potential Authorized Collectors, to notify them of the opportunity to serve as an Authorized Collector in the MED-Project Program. MED-Project began good-faith negotiations with all Potential Authorized Collectors that expressed interest in participating and included all eligible sites in the Program within 90 days of receiving a signed written offer to participate. MED-Project exceeded its Plan goal of establishing 150 Collection Sites by the end of the Reporting Period. Additionally, to achieve proportionality between Manufacturer Program Operators and meet the collection coverage standards in 410 ILCS 720/25(j), MED-Project conducted target outreach to Potential Authorized Collectors and established Collection Sites or Mail-Back Distribution Locations in all 17 of the rural counties specified by the Agency in their September 5, 2023, letter from Allison Fry, EPS II, Materials Management and Compliance Section, to Jim Wilson, Lead Director, Legal and Compliance, MED-Project (Calhoun, Clark, Gallatin, Hardin, Henderson, Jasper, Kendall, Lee, Marshall, Mason, Massac, Menard, Moultrie, Pope, Putnam, Stark, and Warren). See figure 1 for a map of MED-Project Collection Sites and Mail-Back Distribution Locations that were active during the Reporting Period.

Objective 2: Collection of Unwanted Medicine

During the Reporting Period, MED-Project collected Unwanted Medicine from Illinois residents via collection receptacles and Mail-Back Packages distributed at Mail-Back Distribution Locations. Mail-Back Packages were also distributed to residents via the MED-Project Call Center and MED-Project Website, which were available to all residents, including those who are homeless, homebound, or disabled and those who live in rural counties where access to Collection Sites may be limited. In total, MED-Project collected 149,564.0 pounds of Unwanted Medicine. More details can be found in Section III above.

Objective 3: Call Center and Website

MED-Project established the MED-Project Call Center where residents can order Mail-Back Packages, obtain information about disposal options and MED-Project Collection Site locations, and request educational materials about the Program. MED-Project also launched the MED-Project Website that provides educational information about the Program and allows residents to order Mail-Back Packages. Additionally, MED-Project coordinated with the other approved Manufacturer Program Operator to launch a single toll-free number and neutral website for residents to use to contact the individual approved Manufacturer Program Operators and order Mail-Back Packages. More details can be found in Section V.B above.

Objective 4: Educational Materials and Signage

Written materials and in-store signage were made available upon request to all MED-Project Collection Sites and Mail-Back Distribution Locations to provide information

regarding the Program and the opportunities for safe disposal of Covered Drugs available to residents and direct residents to the MED-Project Website for more information. See Section V.C above for more information.

Objective 5: Media Activities

MED-Project promoted the Program by conducting a campaign featuring digital display, online video, and paid social media ads generating more than 17 million impressions. MED-Project also provided information through the MED-Project Website and posted information on social media sites. More details can be found in Section V.C of this report.

Objective 6: Program Funding

MED-Project paid all costs associated with the administration and operation of the Program during the Reporting Period. See Approved Plan Section IX (“The participating Covered Manufacturers in the Program will fairly and reasonably allocate among one another the costs of implementing, administering, and operating the Program so that the share of the costs that is allocated to each participating Covered Manufacturer in the Program is reasonably related to the revenue-based market share of Covered Drugs that the Covered Manufacturer sells in the State.”)




Figure 2: MED-Project Website Home Page




Figure 3: MED-Project Website Medicine Usage Page






Figure 15: MED-Project Website Public Service Announcement Page
