## **EXECUTIVE SUMMARY**

Inmar Rx Solutions, Inc ("Inmar") was approved to operate a Drug Take-Back Program ("Program") on September 26, 2023 pursuant to the Drug Take-Back Act, 410 ILCS 720. The approved Drug Take-Back Program Plan ("Plan") requires that Inmar submit an Annual Report detailing the implementation of the Drug Take-Back Program during the previous calendar year. This Annual Report is for the period between January 1, 2024 and December 31, 2024 ("reporting period"). All capitalized terminologies used herein are the same as those used in Inmar's approved Plan dated July 1, 2023 and written in the Drug Take-Back Act, 410 ILCS 720/10.

The following information contained within this Annual Report mirrors the requirements outlined in Drug Take-Back Act, 410 ILCS 720/50.

## PARTICIPATING MANUFACTURERS

410 ILCS 720/50(A)(1) - A list of the covered manufacturers participating in the drug take-back program during the program year

A list of participating Covered Manufacturers can be found in Appendix A.

#### COVERED DRUGS COLLECTION

410 ILCS 720/50(A)(2) - The total amount, by weight, of covered drugs collected and the amount, by weight, from each collection method used during the program year, reported by county

Throughout the reporting period, Inmar collected Unwanted Covered Drugs by means of Authorized Collectors (Collection Receptacles), Mail-Back Distribution Sites, and Mail-Back Services. These services, which include Standard Mail-Back Envelopes and Inhaler Mail-Back Envelopes, could be requested via the Program's website or toll-free phone number. During the reporting period, 348 Standard Mail-Back Envelopes and 43 Inhaler Mail-Back Envelopes were ordered through the Program Website or toll-free phone number. Although a Mailer may be ordered through the Program's website, toll -free phone number, or taken from a Mail-Back Distribution Site, it does not guarantee the envelope will be returned by the Consumer. The below table represents the total weight collected in pounds by each of these mentioned Collection Methods. The total weight of Covered Drugs collected by county is available in Appendix B.

## **COLLECTION SYSTEM**

410 ILCS 720/50(A)(3) - The total amount, by weight, of covered drugs collected from each collection site during the prior year 410 ILCS 720/50(A)(4) - the following details regarding the program's collection system:

- (A) a list of collection sites, with addresses;
- (B) collection sites where mailers to program collection sites, for dissemination to consumers, and education and outreach materials were made available to the public;
  - (C) dates and locations of collection events held; and
  - (D) the transporters and disposal facility or facilities used to dispose of the covered drugs collected

#### I. Authorized Collection Sites

Appendix C lists each of Inmar's Authorized Collection Sites that maintained a Collection Receptacle in the state of Illinois with the total weight of Unwanted Covered Drugs collected for each site. During the reporting period, Inmar had 474 Authorized Collectors participating in the operations of a Collection Receptacle and collected a total of 71,107.41. There were four closures during the reporting period, but Inmar supplemented these closures by securing additional Authorized Collectors in those counties.

#### II. Mail-Back Distribution Sites

Appendix D lists each of Inmar's Mail-Back Distribution Sites. During the reporting period, Inmar had 115 Mail-Back Distribution Sites participating across the state of Illinois and collected a total of 208.72 pounds of Unwanted Covered Drugs. The average weight of the returned mailer was approximately 2.5 ounces (0.16 pounds). Inmar distributed 5,240 Standard Mail-Back Envelopes to participating Mail-Back Distribution Sites during the reporting period. There were 3 closures during the reporting period, but Inmar supplemented these closures by securing additional Mail-Back Distribution Sites in those counties

Inmar did not host any collection events in 2024.

## PUBLIC EDUCATION AND OUTREACH

410 ILCS 720/50(A)(5) - A description of the promotion, education, and public outreach activities implemented

#### I. Printed Materials & Signage

In accordance with 410 ILCS 720/45, Inmar provided easily accessible educational materials on the Program website and to participating Authorized Collectors and Mail-Back Distribution Sites so they can provide these materials to residents. All materials will leverage explanatory graphics to aid in comprehension, and will be easily understandable by interested parties with varying levels of English proficiency.

The materials promote proper management of drugs, discourage Consumers from disposing of drugs in household waste, sewers, or septic systems, and inform Consumers about the risks of Covered Drugs as it pertains to drug abuse and accidental poisoning. The materials provide options on how to participate in the safe disposal of Covered Drugs and other Program advocacy.

Inmar developed consumer-facing signage in the form of magnets and stickers that are placed on the Collection Receptacles at Authorized Collection Sites that outlines what can be accepted in the Collection Receptacle and clear graphical instructions for proper use.

#### II. Media Communication Methods

## A. Programmatic Media

Programmatic Media provides targeted display ads on browser sites on internet capable devices (smart phones, computers, tablets, etc.). Inmar ran ads across a prequalified list of over 200,000 domains including a variety of retail websites, Google, and Facebook. The programmatic targeted ads ran for six weeks leading up to the DEA's National Prescription Take Back Days in April and October of 2024. Impression metrics are reported directly from the individual websites that the ads are placed on and are reported on a per campaign basis. The two programmatic campaigns garnered a total of 750,554 impressions. Examples of the Programmatic ads are in Appendix E, Figure(s) 8.

## B. Influencer Marketing and Social Media

Influencer marketing is a content creation tactic used to drive awareness and education to a targeted audience through blogs and social media outlets. Influencers create authentic content around their everyday lives and interests while weaving the story of prescription drug take-back into their content. Influencer content is converted into paid ad units across social platforms and then targeted to community members across the state of Illinois.

Paid advertisements for influencer content were run on a variety of platforms including Google, Instagram, and Facebook and drove towards a specified impression goal. Inmar ran several social media influencer campaigns concurrently with other traditional and digital media campaigns. Inmar posted two social media posts per month per platform (Instagram, Twitter, and Facebook) for a total of 72 posts.

Influencer campaigns were deployed quarterly starting in January 2024 and ending in December 2024, totaling 1,770,183 impressions. A sample image for social media and influencer marketing can be found in Appendix E, Figure 9. The dates and results of each media communication campaign are listed in Appendix E, Table 1.



## C. Program Website & Toll-Free Phone Number

To comply with 410 ILCS 720/45, Inmar coordinated with other Approved Operators to launch a single, joint website with a neutrally branded landing page (<a href="www.medtakebacklllinois.org">www.medtakebacklllinois.org</a>) and phone number (844-482-5322). The Approved Operators selected a third-party vendor to develop and host the single website that provided residents with an interactive map displaying all Operators' Collection Sites and Mail-Back Distribution Sites. Updates to the website are ongoing as new locations are acquired. Residents were able to navigate from the joint website landing page to each Operator's independent website. Inmar's independent website (<a href="www.safemedicinedrop.com">www.safemedicinedrop.com</a>) provided an opportunity for residents to request Standard Mail-back Envelopes and Inhaler Mail-back Envelopes, along with access to educational material. Potential Authorized Collectors interested in participating in the Program and participating Authorized Collectors in need of resources were able to request more information and support through the Operators' independent website.

Approved Operators coordinated to operate a toll-free call center for Consumers to call to learn more about the Program and drug disposal best practices. Consumers were able to request information about the nearest disposal site or request a prepaid Mailer be sent to their residence. The single Program website and phone number went live on May 1, 2024.

## Transportation and Disposal

410 ILCS 720/50(A)(5) - A description of how collected packaging was recycled to the extent feasible

Inmar utilizes a serialization unique identification system imprinted on every Inner Liner and Mailer to track Inner Liners and Mailers from initial shipment through destruction as described in the approved Plan, meeting all federal, state, and local regulatory requirements, pursuant to 410 ILCS 720/25(g)(1-3). Collection Receptacle Liners are packaged and sent by the Authorized Collector, via common carrier to the Plan's licensed DEA Reverse Distributor-Collector. A full Mailer will be directly shipped by residents, via common carrier to the licensed DEA Reverse Distributor-Collector. Upon receipt of the full Inner Liner(s) and Mailers, the licensed DEA Reverse Distributor-Collector will record all required data:

- Date received
- Serialized barcode label information
- Tracking information (Collection Receptacle containers only)
- Weight
- Date transported to disposal facility
- Disposal Date

All Unwanted Covered Drugs shipped directly to Inmar's Service Providers will be transported by common carrier to the appropriate disposal facility to be incinerated quickly, securely, efficiently, and in accordance with all DEA requirements. Inmar's Service Providers are responsible for all DEA Form 41 record keeping requirements.

#### **Recycling of Collected Packaging to the Extent Feasible**

While DEA regulations prohibit handling or opening of collected Inner Liners and Mailers after deposit into a Collection Receptacle per 21 CFR 1317.75(c), Inmar promotes pre-disposal separation of drug packaging by consumers to facilitate recycling where feasible.

To support environmentally responsible disposal, educational materials, available on the Program Website and at Collection Sites, advise consumers to remove medications from their packaging where appropriate and recycle the packaging through their local recycling programs.



Inmar periodically reviews opportunities for recycling collection receptacle components and transport materials to determine feasibility. While DEA and DOT regulations restrict post-collection processing, Inmar evaluates whether any materials, such as outer packaging of mailers, could be diverted from waste streams in compliance with federal regulations.

#### **Disposal Methods & Environmental Considerations**

All collected Unwanted Covered Drugs are incinerated at licensed disposal facilities. Some disposal facilities utilize waste-to-energy incineration, which allows for energy recovery from the disposal process. A list of disposal facilities and their respective disposal methods is included under Collection Systems section IV.

All Service Providers involved in collection services, transportation, or disposal will comply with The Drug Take-Back Act, The Controlled Substances Act, 21 USC SS 801-971 and 21 CFR SS 1317; United States Department of Transportation Hazardous Materials Regulation, 49 CFR parts 100-185; Board of Pharmacy, and all applicable state and federal law.

## Program Effectiveness and Evaluation

410 ILCS 720/50(A)(5) - An evaluation of the program's effectiveness in collecting covered drugs during the program year and of any program changes that have been implemented

During the reporting period, the Inmar Drug Take-Back Program successfully operated in compliance with all elements outlined in Inmar's approved Plan and as required by 410 ILCS 720.

#### **Convenience Standard Compliance:**

Inmar met the Convenience Standard set forth in 410 ILCS 720/25(j) during the reporting period by ensuring the required number of Collection Sites per county through Authorized Collectors and Mail-Back Distribution Sites.

- Inmar established the required number of Authorized Collection Sites in 94 counties.
- In the 8 counties where sufficient Authorized Collectors were unavailable, Mail-Back Distribution Sites were implemented to supplement collection access.
- Compliance was achieved while maintaining service continuity despite site closures, with additional Authorized Collectors or Mail-Back Distribution Sites secured to offset any location losses.

#### **Coordination with Other Operators & Public Access:**

- Inmar collaborated with other Approved Operators to launch and maintain a single, joint website
  (www.medtakebackillinois.org) and a dedicated toll-free number (844-482-5322) for residents to easily access
  information on disposal options.
- This centralized system streamlined consumer engagement and provided access to statewide collection services, enhancing program effectiveness.

#### **Collection Performance & Outreach Impact**:

- Program data indicated an average collection weight of 150 lbs per location, demonstrating strong utilization of the collection network.
- To enhance accessibility and participation, Inmar will continue to drive awareness through targeted marketing campaigns and adjust outreach efforts based on resident feedback.
- Ongoing evaluations of educational and training materials will ensure continued clarity, accessibility, and efficiency for both consumers and participating locations.

#### Compliance with Safety, Privacy & Security Regulations:

- All policies and procedures for collecting, transporting, and disposing of Unwanted Drugs, as outlined in the approved Plan, were followed without incident.
- All contracted service providers and Authorized Collectors maintained compliance with:
  - o HIPAA & Protected Healthcare Information (PHI) regulations for consumer privacy protection.
  - DEA & DOT requirements for secure drug collection, transportation, and disposal.
- There were no reported safety or security concerns during the reporting period.








Figure 1 - www.safemedicinedrop.com Landing Page




Figure 2 - www.safemedicinedrop.cm Mail-Back Request Page with Educational Material Links - State of Illinois






Figure 3 - Images of the joint website www.medtakebackillinois.org, which was utilized May 1 - December 31, 2024
