

#### **Types of Permits**

Which permits do we track?

#### The IL Sierra Club tracks a few main types of permits:

- <u>National Pollutant Discharge Elimination System</u>
  <u>(NPDES)</u>
  - Required when anyone wants to discharge pollutants through a point source into US waters
- <u>404 Permit</u>
  - Required to regulate the discharge of dredged material into US waters
- <u>401 Permit</u>
  - Required any time there's activity that may result in a discharge into US waters

#### **Nutrients**

Nutrient inputs are a big problem for both Illinois waterways and the Gulf of Mexico into which polluted water leaving Illinois ultimately drains.

#### Lessons learned

- Edutainment for the general public
  - Especially since this is mostly virtual
- Brief and flexible for operators
  - Creation of materials and constant outreach
  - Responsive to their other questions and tensions
    - Is nutrient trading supported?
    - Can the NLRS funds be used by WWTF's?
  - Work with consultants to have a potentially broader reach
- Clear and easily translatable for decision makers
  - Support local water initiatives and connect them to resources that can translate into investments and coalition building
- Engaging local media takes time and relationships
  - Press releases
  - Pitching and calling into radio stations for environmental updates








#### **Sharing Experience**
