



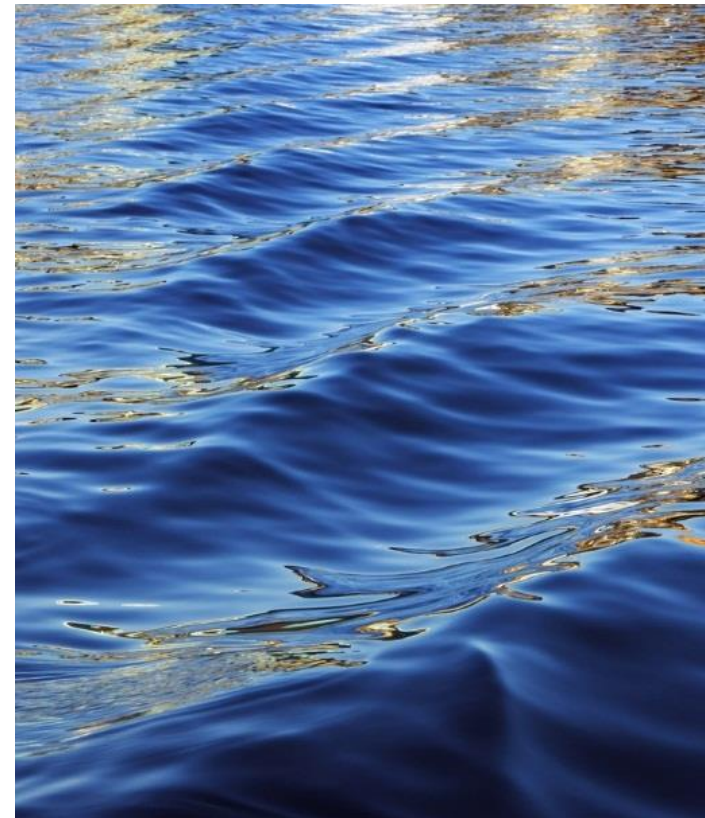

CBMP Goals

- Awareness: Increase awareness of water quality issues and BMPs
- Participation: Increase farmer participation in programs and adoption of BMPs
- Demonstration: Using the Nutrient Loss Reduction Strategy as a guide, demonstrate and track adoption of BMPs



Cover Crop Training Initiative

- Utilize 5 regional cover crop specialists to provide training, education and outreach to promote use of cover crops for nutrient management in production agriculture
- Cover crop specialists will:
 - Set up meetings across the state
 - Partner with local SWCD, NRCS and Ag Departments at Community Colleges to establish a network for education and outreach
 - Develop cover crop plots across the state at community colleges and on farm locations to encourage student instruction and demonstration

Three locations have been identified to add edge of field water monitoring to farm scale demonstration sites that have implemented one or more BMPs.

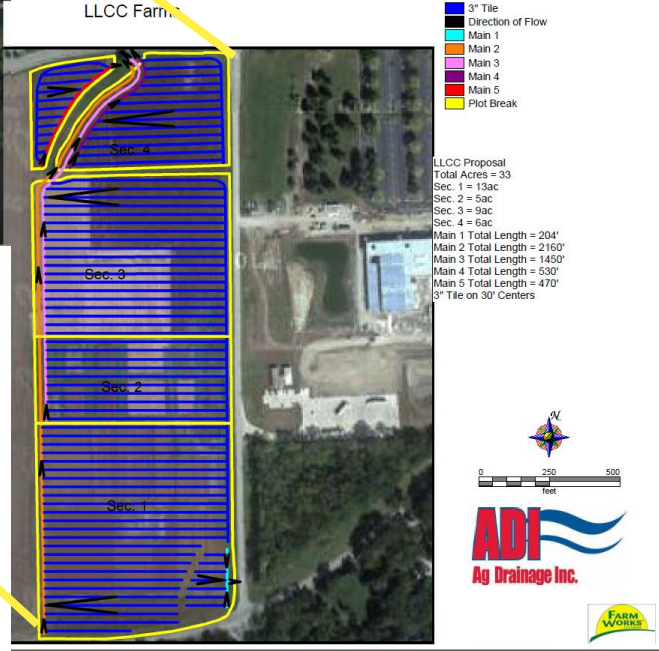
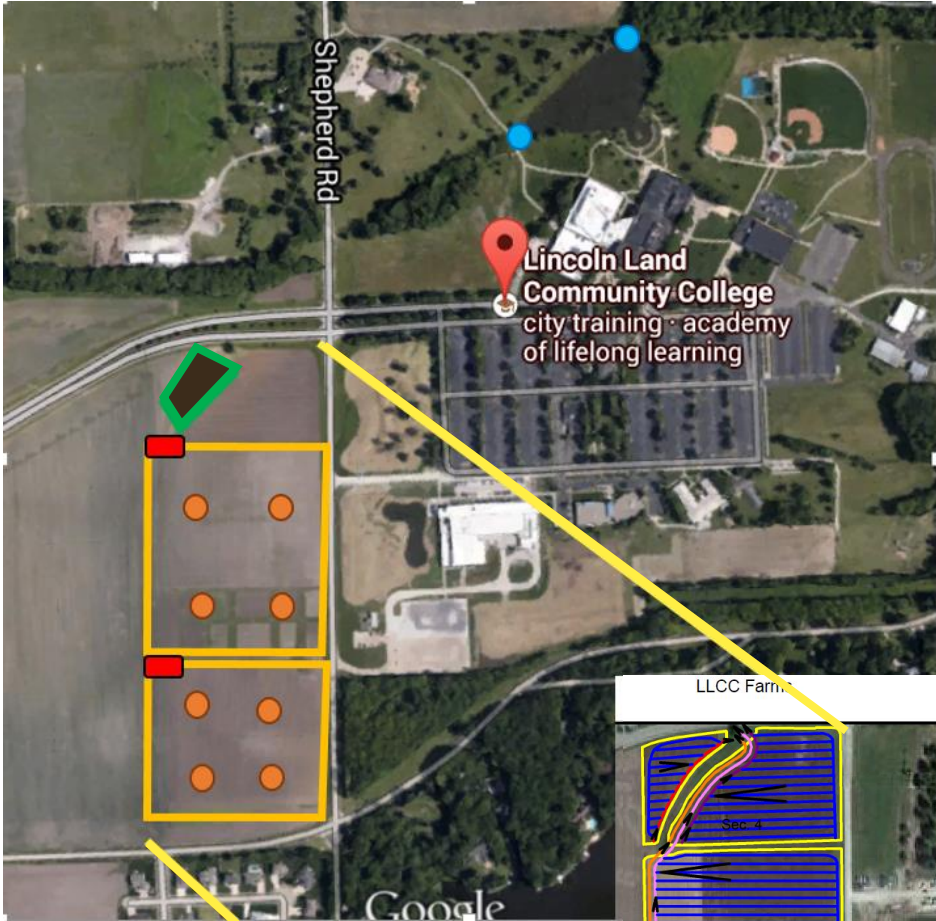

Demonstration Project

Equipment will be purchased and loaned out to local SWCDs to host weekly **Water Testing Open House** events for farmers to bring in water

Local Community College faculty will have access for using with ag classes



Collaborations

Trees Forever – \$20,000

Illinois Buffer Partnership Over the past 15 years, this program has provided assistance to more than 200 demonstration projects across Illinois. Over 4100 acres of conservation buffers have been planted, protecting more than 57 miles of Illinois streams.

Kaskaskia River Watershed Project Heart Lands Conservancy - \$20,000

This project will work directly with SIU-C and Dr. Karl W. J. Willard to provide an update and analysis of 14 monitoring locations across the Kaskaskia River basin. The first study was done approximately 10 years ago. This project will assess whether water quality trends improved, declined, or remained the same



Collaborations

Vermilion County Water Sampling Project - \$4,000

Illinois CBMP provided cash support to the Vermilion County SWCD. Vermilion County SWCD wanted to collect current baseline data for nitrates in the tributaries of Lake Vermilion. The micro grant enabled the SWCD to cover the water sampling costs from April through August 2015.

American Farmland Trust (AFT) Partnership in Lake Mauvaise Terre - \$4,000 cash support and \$7,650 in-kind support

Illinois CBMP is supporting AFT with cash and in-kind support for education and outreach to watershed farmers and landowners in Lake Mauvaise Terre

N-WATCH

Sentinel Site Program

- The sentinel site program provides a way to watch the dynamics of plant-available N in the upper two feet of the soil profile over time by following abbreviated and anonymous local farmer N-WATCH Reports.
- CBMP sponsored 300 N-WATCH sites – 200 priority Watersheds and 100 at-large

- Springfield's City, Water, Light and Power

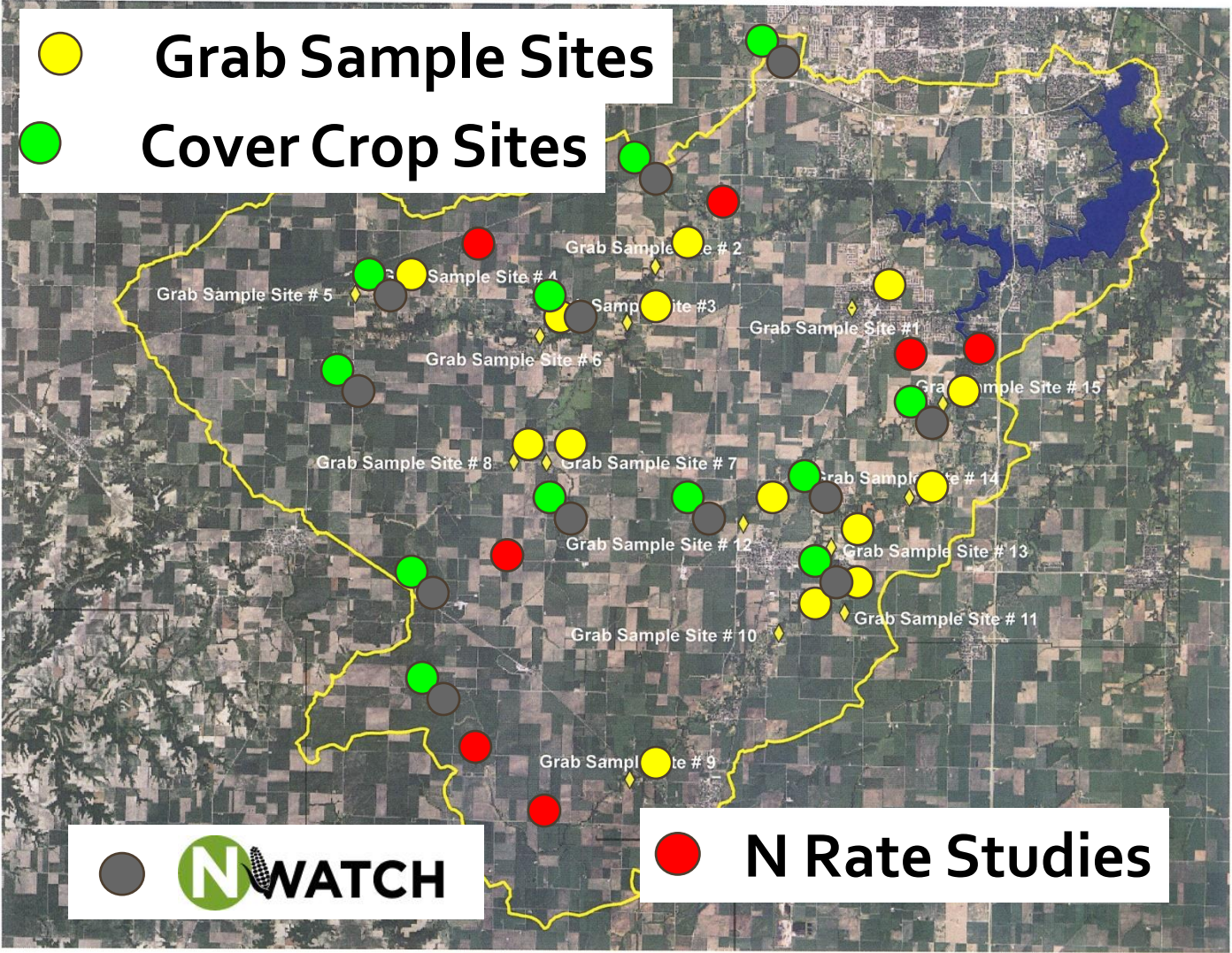
Project Goals

- Achieve a sustained reduction in nitrate loading from agricultural non-point sources
- Help understand the trends in nitrate levels within the Lake Springfield Watershed

Lake Springfield Watershed Nutrient Management Project

Year One Outcomes

- 27 producers are participating
- 12 farmers, 12 N-WATCH sites and 504 acres cover crops
- 6 farmers - Nitrogen Rate and Timing Studies.
- 9 farmers – Additional N-WATCH sites
- Twice weekly monitoring of 23 stream sites for nitrate nitrogen.



Lake Springfield Watershed Nutrient Management Project

Year Two Goals

- Increase the number of participants by scheduling a Lake Springfield Bus Tour of the watershed on July 21, 2015.
- Establish N-WATCH Sentinel Sites within watershed with aggregated results posted online at www.illinoiscbmp.org
- Increase the number of cover crop acres by 500
- Increase the number of N-Rate Trials
- Demonstration farm field days at Lincoln Land Community College
- Continue to collaborate on 319 EPA Grant

Promotional Results

- Over 1,100 attendees for the 11 meeting roadshow
- Tele Town Call reached over 93,000 high value personalized “touches” were made to spread awareness of NLRS and CBMP with two nights of calls.
- Web hits to Illinois CBMP increased after each tele town call meeting as well.



Roadshow Survey

Results

- Over 90% have tried nutrient management practices and over 50% and done so for over 10 years
- Over 90% have tried no-till or strip-till practices
- Over 90% wait until the soil temps fall to 50 degrees to apply anhydrous ammonia
- Over 80% use a nitrification inhibitor
- Over 40% have tried cover crops
- Over 70% that attended will try a new practice or a combination of practices for the first time
