## **Meeting Minutes**

#### **Welcome and Member Updates**

Eliana Brown welcomed everyone to the meeting and encouraged members to share their updates.

Gina Cassidy, a graduate student working with University of Illinois Extension, is interested in green infrastructure and stormwater and has been working on a watershed plan for the Salt Creek watershed primarily in Effingham county. She is working on factsheets and wants to highlight different places that are using green infrastructure for stormwater management, targeted towards decision-makers to fund these projects. Holly Hudson shared that CMAP is continuing with their local technical assistance program and have helped several communities so far. In the past, they had a great example in south Elgin that used the center for watershed protection's ordinance worksheet, and they used some of their recommendations. They will be working with Midlothian on a stormwater fee feasibility study and are continuing with watershed-based plan development in the Fox River Watershed split between Kane and DuPage counties.

- Eliana Brown: prior to Midlothian, had you done any for other communities?
- Holly Hudson: Stormwater plans but this is the first having to do with a fee study. They did a
  guidance document on creating a stormwater utility fee but this is the first study. Holly will
  check with others at CMAP.
- Eliana Brown: Gina, you may want to reach out to Holly for some examples on GI work.
- Sally McConkey: as I recall, Kane and DuPage counties have a stormwater ordinance. Is there a chance of scaling up the plans county-wide?
- Holly Hudson: That's a good question, we should look into that.

Mary Beth Falsey shared that DuPage County Stormwater created a green infrastructure inventory tool and will be sharing it with their municipal partners – they have 41 municipalities that they work with frequently. They will add their projects then they will share it on their website and the general public can add their projects as well. They are continuing with the webinar series and are hosting the Environmental Summit on Jan 28, a more technical half-day webinar called Beyond the Basics on Feb 28, and additional residential and technical webinars. There is one next week on critters in the streams and many others.
